Grant Request Summary	This project is intended to increase communication and connectivity with stakeholders while increasing resilience in the community overall. Technology and software to communicate with field workers and for the emergency operations center will increase safety and a common operating picture during disasters and on blue-sky days. Educational and example preparedness materials will make our community members less vulnerable to natural disasters, namely our underserved population.
Requested Grant Amount	USD 25,000.00
Fund Use	The requested funds will be used to purchase communications and data equipment for internet redundancy in the Guilford County Emergency Operations Center (EOC) and in the field. This includes satellite and 5G internet capabilities and hybrid meeting technology expansion. Additionally, enhancements to software that already exists in the County to provide safety awareness and a common operating picture would be purchased.
Grant Request Overview	It is expected that the funds would allow for resources to create redundancy for the County Emergency Operations Center (EOC) that does not currently exist with traditional fiber internet providers. Also, with the limited space in our current EOC, it will allow for more efficient hybrid activations where partners can share information in real-time to facilitate a common operating picture for a response to emergencies and disasters. Enhancements to the current alert and warning software used by the county will also give mechanisms to message hazards to field employees. Lastly, preparedness materials purchased will be distributed into the community with a focus on under-served populations creating a more resilient public and community. Resilience in the home translates to resilience in the County overall.
