### I. Evaluation and Selection Process

An Evaluation Committee comprised of personnel from various departments will have responsibility for reviewing and evaluating all proposals and required documents submitted in response to this RFP. All proposals properly

submitted and received will be evaluated against the award criteria outlined in this RFP. The absence of required information may result in exclusion of the proposal from further analysis or evaluation.

The County reserves the right to reject all proposals or waive technicalities in order to award a contract, which may be determined to be in the best interest of the County. The County also reserves the right to make the award in whole or part. The County reserves the right to include outside consultants to assist in the evaluation process.

## **II. Award Criteria**

It is the intent of Guilford County to make an award to a single or multiple Providers deemed to be fully qualified and best suited among those submitting proposals on the basis of the evaluation factors included in this RFP.

Price shall be considered but shall not be the sole determining factor. Once the proposals are ranked and the most qualified Provider(s) are determined, the County may conduct further negotiations, and/or request presentations from Provider(s) to further assist in the clarification of information and selection process.

The Evaluation Committee will be guided by the the point system, which has 100 points as the maximum total.
