2025-275 FY25-26 NORTH CAROLINA DEPARTMENT OF PUBLIC SAFETY

(NCDPS) YOUTH FOCUS GRANT

Background: NC Department of Public Safety (NCDPS) would like to continue

assisting with funding the Youth Focus "HEARTH Transitional

Living Program" in Guilford County during FY 2025-26. NCDPS awarded Youth Focus 'start-up' funds for the current model during

FY22. Guilford County served as a funding facilitator for funds in FY23, FY24, and FY25. The HEARTH program has been serving clients in Guilford County since 2017 and within the current model since November 2022. The current HEARTH program model provides supportive housing for male, female, and nonconforming youth ages 18-21 who are experiencing homelessness or young adults who have aged out of the foster care system, with on-site supervised, yet independent living environment. During the program, youth gain needed independent living skills. Transitional housing along with living expenses and programming relating to independent living skills are provided to all participants. Participants set transitional goals specific to their situation to transition from the program into stable housing; to obtain their high school diploma or a GED and /or a college degree; receive vocational training to gain and maintain employment; all to fulfill a transition into independent living. The program accepts referrals statewide and expects to serve approximately eight (8) youths this fiscal year with an average stay of 275 days.

NCDPS has requested that they use Guilford County as a funding facilitator to the Youth Focus "HEARTH Transitional Living Program" with monthly reimbursements during FY 25-26. NCDPS will take on all responsibilities for vetting the program's services and expenditures and will disburse funds to Guilford County monthly to reimburse Youth Focus "HEARTH Transitional Living Program". Guilford County will not be required to complete any monitoring or financial reviewing; only schedule monthly reimbursements based on NCDPS disbursements.

Approve receipt of FY25-26 NCDPS Youth Focus Grant from DPS for the HEARTH Transitional Living Program and the contract, in substantial form, that the County agrees to serve as a payment processor of the approved funds of \$198,300, effective July 1, 2025 through June 30, 2026, and adopt the grant project ordinance for *FY26 NCDPS Youth Focus Grant* in the amount of \$198,300, with \$198,300 in federal state/funds.

2. 2025-465 BUDGET AMENDMENT: FY25 PAYTEL FUNDS RE-ALLOCATION

2025-471 HHS-PUBLIC HEALTH BUDGET ALIGNMENT, NCDHHS: AGREEMENT

ADDENDUM ALLOCATIONS (\$631,754)

Background: The North Carolina Department of Health and Human Services

(NCDHHS) awards annual Public Health appropriations to local health departments through a State Consolidated Agreement. This agreement specifies funded activities across various divisions and ensures that resources are directed toward evidence-based and community-driven public health priorities.

Guilford County Public Health (GCPH) requests approval to amend the FY2026 budget to align with awarded state funds. These budget adjustments are intended to maximize efficiency, support program integrity, and sustain essential services across divisions.

Clinical Services:

The Clinical Services Division received increased Maternal Health and Communicable Disease funding to strengthen High-Risk Maternity Services and enhance Pandemic Recovery and Disease Control operations.

Maternal Health received additional funds in the amount of \$27,903 bringing the full award for FY2025-26 to \$242,996. Additional funding will standardize high-risk maternity protocols, expand STI tracking and treatment systems, and ensure evidence-based communicable disease prevention practices. The Maternal Health Program served 1,409 clients year-to-date.

Family Planning received a funding reduction in the amount of (\$21,419) the full award for FY2025-26 \$571,662. The reduction will decrease the number of family planning devices purchased with state funding.

Communicable Disease received additional funds in the amount of \$500,706 bringing the full award for FY2025-26 to \$1,010,444. The Communicable Disease team investigates an average of 93 cases per month. This can include illnesses such as TB, food-borne illness investigation, measles investigation, etc. Additional funding will be used to cover communicable disease vaccines, purchase freezers for both Greensboro and HP clinics and pay salaries for hourly nurses. Total Increase for Clinical Services: \$507,190

Community Services:

Care Coordination Program received additional funding of \$3,442 bringing the full award to \$169,324 for FY2025-26. This was provided to expand Care Coordination for Children (CC4C) by offering non-Medicaid case management to improve child health outcomes and support at-risk families. Care Coordination currently

serve 35 non-Medicaid eligible children.

Total Increase for Community Services: \$3,442

Health Education:

The Integrated Targeted Testing Services (ITTS) program received expanded funding of \$52,681 bringing the full award to \$526,814 for FY2025-26. This will enhance outreach and testing efforts essential for prevention and early intervention of HIV, Syphilis, and other STIs. Supports deployment of evidence-based testing protocols, integration of preventive education, and testing within community health settings. ITTS teams perform an average of 273 tests per month.

Total Increase for Health Education: \$52,681

Administration

General Aid to County reduction of (\$50,000) bringing the full award to \$228,875 for FY2025-26. Funding used to support public health's 10 Essential Services activities. Public Health along with all other NC Health departments received this funding in FY2023-24 and FY2024-25, funding was not reallocated for FY2025-26.

Total Reduction for Administration: (\$50,000)

Allied Health:

WIC client services received additional \$118,441, bringing the full award 1,832,715. WIC client services funding supports prenatal and early childhood nutrition services. Continues to fund salaries and fringe benefits for WIC staff serving pregnant women and children from birth to age four. In FY2024-2025, WIC served 13,685 clients, achieving 105.23% of the state-assigned caseload. The current caseload as of October 2025 is 13,005.

4. 2025-466 BUDGET AMENDMENT: RECEIVE FUNDS FROM THE FY26 HIGH

POINT ABC BOARD GRANT

The High Point ABC Board annually awards various non-profit and local government organizations with grant funds. These grant funds are generated by revenue obtained from the sale of alcohol. Per the established guidelines, this ABC Board must provide these funds for alcohol-related law enforcement, education, and rehabilitation purposes. The Sheriff's Office has been awarded \$6,500.00 towards the DWI Task Force (DWITF), to be used in conjunction with the educator officer portion of the task force. The DWITF has one deputy, who is designated as the educator officer. This position is a requirement in order to receive grant funds from the State of North Carolina. The DWITF is only funded by the state at a twenty-five percent (25%) level for salaries. The funds from this grant will assist the task force in fulfilling a portion of its mission, which is educating the public against the dangers of impaired driving and alcohol abuse.

1.) Funds cannot be used for any salaries

The only stipulations of the grant are as follows:

- 2.) Funds must be used for activities in the High Point area
- 3.) Fund usage must be related to alcohol education and/or treatment

The High Point ABC Board grant does not require any matching county dollars. Also, it does not obligate the Sheriff's Office or the county to create a program that must be maintained in the future. The funds will merely supplement the available budget for the DWITF. The task force will use these funds to purchase additional education

tools geared towards the prevention of impaired driving and underage consumption of alcohol. These tools would be used when the DWITF educator holds monthly events in the High Point area. The deputy in the DWITF educator position already attends several monthly events at driver's education classes, church and community events, and local festivals in High Point.

Background:

Walmart Spark Good grants are local cash awards, ranging from \$250 to \$5,000, that support eligible non-profits, schools and government agencies in their communities. The grants are part of Walmart's broader Spark Good program and are awarded by individual Walmart and Sam's Club facilities to address unique local needs, such as food distribution, health programs, and community clean-up projects. Applications are typically accepted on a quarterly basis through a dedicated online portal. The Guilford County Sheriff's Office submitted a funding request for a grant to the Reentry Food Drive occurring in November. Background: The Guilford County Sheriff's Office requires the ongoing purchase

Equipment. Gall's, LLC, was the only bid received however the pricing is favorable. Gall's has recently purchased several local

Public Safety Uniform and PPE suppliers such as American Uniform

Sales, Inc. Gall's currently serves as the Sheriff's Office

contracted vendor for uniforms and equipment and has provided

consistent, reliable service historically.

The Sheriff's Office requests to award the contract with Gall's, LLC for a period of three (3) years, with the option of two (2) additional one-year extensions. The annual contract amount will not exceed \$500,000.00.

3. 2025-452 VEHICLE MAINTENANCE CONTRACT AMENDMENTS

On December 21, 2023, the Board of Commissioners awarded contracts for vehicle maintenance and repair services for all County vehicles. In addition to monitoring spending trends, the Fiscal Year

2026

Budget included additional funds:

- \$75,000 in the General Fund for Fleet Operations based on increased in maintenance trends.
- \$204,000 in the Internal Service Fund Risk Management, for maintenance to vehicles involved in accidents.

These two (2) adjustments result in a need to increase contracts by \$361,815 for Fiscal Year 2026 and six (6) months of Fiscal Year 2027.

Additionally, the County has adjusted estimated not to exceed amounts based on current spending trends and will reduce those estimated amounts for specific vendors by \$908,185. Those amounts will be shifted to other vendors based on current spending trends. The total net increase across these adjustments is \$361,815. There is no impact to the overall budgeted amounts.

Requested Action: Amend the agreement with Casey's Tire and Automotive, Inc. in the

amount of \$325,000 for the remaining year of the initial term, bringing the initial amount to a total of \$845,000; and amend the agreement

with JP Thomas & Co, Inc., doing business as Thomas Tire in the amount of \$700,000, for the remaining year of the initial term, bringing the initial amount to a total of \$2,275,000; and amend the agreement with Hudson Autoworks in the amount of \$245,000, for the remaining year of the initial term, bring the initial amount to a total of \$1,020,000.

APPROVE NC DEPT. OF COMMERCE RURAL BUILDING REUSE GRANT APPLICATION FOR EASTERN AIR EXPRESS, LLC.

Background:

Eastern Air Express, LLC (company) is an aviation company specializing in domestic and international charter passenger and cargo flight services, currently headquartered in Kansas City, Missouri. The company is planning to relocate Eastern Air Express LLC's operations from Kansas City International Airport (MCI) in Kansas City, Missouri, to Piedmont Triad International Airport (GSO) in Greensboro, North Carolina.

Currently, Eastern Air Express, LLC employes three hundred and sixty-nine (369) full-time employees. Fifty-eight (58) of these are based in Kansas City, MO, consisting of five (5) mechanics and fifty-three (53) office staff who support operations and administrative functions. This project would relocate the full Kansas City team to Greensboro. The company also has fifty-four (54) full-time and sixty-five (65) part-time employees in Miami, FL., one (1) full-time employee in Youngstown, OH, and seven (7) full-time employees in Killen, TX. and seven (7) full-time employees who are currently located in Greensboro, NC. In addition, the company plans to expand its maintenance workforce in Greensboro by approximately thirty (30) mechanics. The proposed new headcount in Greensboro, NC would be between 99 and 122 jobs. The company is projected to create fifty (50) new jobs over the next two (2) years with an average annual wage of \$101,836.07 and pays 64% of employee health benefits. The average Guilford County private sector wage (2025) is \$60,195 as published by the NC Dept. of Commerce.

Eastern Air Express, LLC. is applying for a NC Dept. of Commerce Building Reuse and Infrastructure grant in the amount of up to \$500,000 and is seeking to upfit and lease an approx. 84,227 sq. ft. building located at 7306 W Market St Greensboro for a long-term lease with the Piedmont Triad Airport Authority. The Piedmont Triad Airport Authority is the owner of the property. Any improvements made on the property with the Building Reuse Grant, should it be approved, would remain on the property for use by future lessees if Eastern Air Express, LLC vacated the lease.

The total project (construction) cost is \$3,900,449.93. The grant, if approved, will provide the necessary square footage for anticipated growth of the company in support of flight and fleet maintenance operations. The project site is a hangar facility with dedicated inventory storage space and is currently in deteriorating condition. The hangar is located on PTI and holds strategic value due to its airside access. It accommodates a single narrow-body aircraft with a single bay configuration. The facility will play a key role in supporting aviation operations and has the potential to significantly enhance service capabilities once renovated. The property renovation will include roof repair or replacement, construction of new office space, repair of existing hangar door, repaving and expansion of an existing parking lot, installation of new retaining walls, reconstruction of walkways leading to a side entrance, complete repainting of the interior and exterior of the building. The project will enhance the functionality, safety, and aesthetic appeal of the property while extending its usable space and improving overall infrastructure.

Eligible applicants for Building Reuse Grants are units of local government located in either a Tier 1 or Tier 2 county, or a rural census tract in a Tier 3 county. Guilford County is a Tier 2 county.

EDPNC requires a 5 percent local match for building reuse grants. The maximum amount required from Guilford County would be \$25,000 if the NC Department of Commerce approved the requested maximum grant of \$500,000. If the NC Department of Commerce approves the grant, funds would be in the form of pass-through funding (a forgivable loan) which then would reimburse the property owner upon performance review and verification by the State. This

Request also includes adoption, in substantial form, of the associated resolution in support of this building reuse grant application.

Approval of this request by the State also establishes a project budget for anticipated revenue from funding sources.

No County budget action is necessary at this point because the grant is still pending approval by the State. County staff will monitor the progress and approval of this application as well as construction work and will bring an appropriate budget amendment at a future time

BUDGET AMENDMENT & INTERLOCAL AGREEMENT WITH THE CITY OF HIGH POINT FOR CREATION OF ONE (1) NEW NAVIGATOR POSITION FOR THE FAMILY JUSTICE CENTER

Background:

The High Point Police Department (HPPD) partners with the Guilford County Family Justice Center (GCFJC) to investigate and support violent crime victims. The department wants to expand its resources to include a GCFJC Navigator to triage referrals from HPPD and assist homicide survivors and other victims of crime throughout Guilford County. The GCFJC has a strong history of providing navigation services for persons seeking assistance who have experienced domestic violence, child abuse, elder abuse, stalking, and sexual assault. (HPPD) wishes to contract with the GCFJC to create a Navigator position funded for two years to expand triage support for the Violent Crimes Unit to include supporting homicide survivors and victims of other crimes, such as child abuse, domestic and sexual violence, and elder abuse, by addressing gaps in connecting community members to essential GCFJC partner services.

Annually, the GCFJC in High Point provides navigation to nearly 6,000 individuals impacted by violence and abuse. Of that, approximately 900 are children and 700 are older adults. The needs of homicide and abuse survivors are complex, and the GCFJC is uniquely equipped to provide expanded services and the supportive resource connections necessary to foster healing and hope after violence.

By creating a dedicated Navigator for HPPD within the GCFJC, HPPD officers can guide citizens to the GCFJC more effectively and efficiently. The dedicated Navigator will bridge service gaps, provide necessary triage and support for victims of violent crime in Guilford County, and connect the dots between HPPD investigations and the broader GCFJC partnership. In addition, the position will help connect homicide survivors as well as victims of elder abuse, child abuse, and underserved populations to the GCFJC for assistance. Year one of the program will be funded through HPPD equitable sharing funds and covered through routine operational funding located in the adopted High Point Police Operational Budget for Subsequent years. The 24-month County cost of the program is estimated to be \$48,872 with \$150,000 budgeted from City of High Point funds through September 30, 2027 (24 months).

Requested Action:

Approve interlocal agreement with the City of High Point for the FJC HPPD Navigator; adopt a grant project ordinance for FY 26/27 FJC HPPD Navigator Grant with \$150,000 in Federal/State Funds and \$48,872 in Transfers from Other Funds (General Fund); and establish one (1) new FTE for a Navigator position at the Family Justice Center associated with the interlocal agreement through September 30, 2027, or as long as funding is available. Authorize a transfer from the General Fund to the project ordinance for \$24,436.

Background:

NORTH CAROLINA GENERAL STATUTE 108A-118 - ESTABLISHMENT OF LOCAL ADULT PROTECTION MULTIDISCIPLINARY TEAM

The General Assembly found that it is public policy of the State of North Carolina to prevent the abuse, neglect, and exploitation of disabled adults and older adults, and therefore promote the establishment of local adult protection multidisciplinary teams. Professionals from disparate disciplines have expertise that can promote the safety and well-being of disabled and older adults and prevent re-victimization. Multidisciplinary reviews of selected cases can lead to a greater understanding of the causes of the abuse, neglect, and exploitation of disabled and older adults.

A multidisciplinary team (MDT) is a group of professionals in a geographic region who commit to working together toward a common goal. An adult protection MDT works to find ways to prevent and respond to abuse (including physical, emotional & sexual), neglect (including self-neglect and caretaker neglect), and exploitation (including financial) of disabled and older adults. According to University of North Carolina School of Government's Adult Protection Network, over 80 counties in NC currently have or are in the process of forming adult protection MDT's. The need continues to grow as per the North Carolina Department of Health & Human Services, 34% of adults aged 65 and older report living with a disability. Guilford County will look to utilize the MDT's through systemic reviews to aide this population and combat the growing statistic that reported cases of abuse, neglect, and exploitation of older and disabled adults across NC have risen 64% over the last ten years. A systemic review MDT may include such activities as: (1) disseminating information about new services, legislation, and policy changes to members of the MDT; (2) increasing community awareness by offering trainings to the community, including older adults, caregivers, clergy, and financial institutions; (3) establishing and reinforcing reporting protocols among members; (4) increasing understanding of the various roles, responsibilities, and limitations of each of the professionals on the MDT; and (5) creating self-help materials for dissemination in the community.

The MDT shall consist of eleven mandatory members, and a maximum of an additional five members representing local agencies

or the community at large can be appointed by the MDT Chair. The eleven mandatory members are outlined below as in the NCGS 108A-118:

- (1) The Director of Social Services
- (2) A staff member of the local department of Social Services, designated by the DSS Director
- (3) A local law enforcement officer appointed by the Board of County Commissioners after consultation with the District Attorney's Office and the local department of Social Services
- (4) An attorney from the District Attorney's Office, appointed by the District Attorney
- (5) The public guardian appointed in the county by the Clerk of Superior Court under Article 11 of Chapter 35A of General Statutes
- (6) A local mental health professional, appointed by the director of the area authority established under Chapter 122C of the General Statutes
- (7) The long-term ombudsman serving in the county, to be appointed by the Office of the State Long-Term Care Ombudsman
- (8) The director of the local department of Public Health or a member of the director's staff, as designated by the director
- (9) A local health care provider, appointed by the local board of health
- (10) A representative from the local area agency on aging, appointed by the director of the area agency on aging serving the county
- (11) A victim advocate from a local domestic violence or sexual assault agency, appointed by the agency's executive director.

Once established, the MDTshall review selected active cases in which disabled or older adults are being served by adult protective services through HHS-DSS, then submit annually to the Board of County Commissioners recommendations, if any, for addressing systemic problems and service gaps that may exist in the delivery of services by public and nonpublic agencies.

Requested Action:

Authorize creation and allow staff to take all necessary actions to establish a Single County Case Review Multidisciplinary Team involving all required members, powers/duties, training, and information sharing required by North Carolina General Statute 108A-118.

B. 2025-473 HHS-PUBLIC HEALTH: APPROVAL OF AGENCY GUIDELINES

Background: North Carolina Local Health Department Accreditation Benchmark

37 states: "The local board of health shall assure development,

implementation, and evaluation of local health services and programs to protect and promote the public's health." Within this benchmark,

Activity 37.2 specifies: "The local board of health shall approve policies for the administration of local public health programs."

Division Directors are required to annually review their assigned agency guidelines and make necessary updates. The most recent comprehensive review was completed in September 2025. The updated guidelines, along with any changes, were submitted to the Health and Human Services Advisory Committee for review on September 24, 2025.

Following this review, the division is now seeking approval of the agency's guidelines from the Board of Commissioners, acting as the Guilford County Board of Health, in accordance with North Carolina General Statue 153A-77. Notable changes for 2025 include a comprehensive update of our agency guidelines focused on enhancing clarity and consistency. Key updates include the consolidation of several guidelines, adoption of a new standardized template, renumbering of guidelines, and reclassification of certain guidelines as Standard Operating Procedures (SOPs) to better reflect their intended functions.

No significant content changes were made, except for Guideline **HE-02**: **Community Outreach**, which was revised to strengthen the planning, implementation, and delivery of outreach and mobile unit services.
