



**GUILFORD COUNTY CONTRACT NO. 90005940
AMENDMENT NO. 1**

THIS CONTRACT AMENDMENT is hereby made, entered into, and effective as of November 1, 2025, by and between GUILFORD COUNTY, a body politic and corporate of the State of North Carolina, hereinafter referred to as the "COUNTY," and CASEY'S TIRE & AUTOMOTIVE, INC., hereinafter referred to as the "CONTRACTOR," and also collectively referred to as the "Parties."

WITNESSETH:

WHEREAS, the Parties entered into a CONTRACT on January 1, 2024, whereby the CONTRACTOR agreed to provide the following goods and/or service(s) to the COUNTY: County wide vehicle maintenance and repair (BID 20160), and

WHEREAS, the initial Contract may be revised or modified with a written Amendment executed by both Parties; and,

WHEREAS, due to an increase vehicle maintenance and repairs, the maximum amount of the Contract needs to be increased;

WHEREAS, the Parties now wish to modify the terms of the Contract; and,

NOW, THEREFORE, the Parties mutually agree that, as of the effective date of this Amendment, the following changes are hereby made to the initial Contract as follows:

CHANGES:

PARAGRAPH 3. PRICE ONLY CONTRACT is hereby modified to change the financial exposure amount from \$520,000.00 to \$845,000.00 and in any event, payment will be made only from budgeted funds in accordance with N.C.G.S. Chapter 159.

JURISDICTION. The Parties agree that this Contract is subject to the jurisdiction and laws of the State of North Carolina. The CONTRACTOR will comply with bid restrictions, if any, and applicable laws, including N.C.G.S. §143-129(j) regarding E-Verify. Any controversies arising out of this Contract shall be governed by and construed in accordance with the laws of the State of North Carolina.

PRIOR AGREEMENTS. All other provisions of the initial Contract and subsequent Amendments and revisions, are hereby ratified and shall continue in full force and effect without change, unless and until revised upon mutual written Agreement of the Parties, or terminated as provided herein.
