The Board of County Commissioners met in a duly noticed regular meeting on May 7, 2026 at 5:30 p.m., in the Commissioners' Meeting Room, 301 W. Market St., Greensboro; North Carolina.

He noted a future 6-acre property located on Freeman Mill Road for housing and workforce training. He noted the first phase of the community is in progress. He encouraged the County to place a mental health support staff at the new High Point Hope Center.

2. Gail Dunham expressed concerns that the Town of Summerfield is going to bid on the water tower project and expressed concerns that the Summerfield Fire Department is not involved.

3. David Smith, High Point resident, spoke in support of the Guilford Clean Power Now organization's commitment to 100% clean energy by 2050.

4. Joanna Pendleton, Guilford County Association of Educators President, thanked the Commissioners for their support of educators. She noted the ongoing work to be done to prioritize public education. She spoke to challenging times and the work to balance the many needs of our community.

Watershed Engineer Brent Gatling introduced the item. He reviewed the proposal to adopt the FEMA's required new flood insurance study to become effective June 10, 2026. He shared the new rate maps and text amendments that must be approved by the Board before the June deadline to allow Guilford County residents to remain eligible for flood insurance and maintain eligibility for FEMA assistance in the event of a natural disaster. He reviewed the County's community outreach efforts to inform the community how the flood maps impact properties. He reviewed the flood plain updates and the text amendment summary.

Commissioner Foster questioned whether the impacted properties are countywide.

Engineer Gatling noted that there are about 46 structures across the county. He noted additionally, there were some structures that were in the flood plain and are now excluded. He shared that our map is specific to the unincorporated areas, and each jurisdiction must adopt similar map updates.

Commissioner Tillman questioned the reasoning for removing a site from the flood plain.

Engineer Gatling noted that it has been some time duration, additional construction, perhaps bridges, or re-routing of water streams.

Director Bell noted the staff recommendations before the Board.

Chairman Alston opened the public hearing and opened the floor for proponents of the item. There being none, he opened the floor for opponents. There being none, he closed the public hearing.

Chairman Alston and Commissioner Jones returned to the regular meeting at 6:43 p.m.

Chairman Alston resumed the presiding chair position and continued with the agenda.

Parks and Recreation Director Dwight Godwin introduced the agenda item. He highlighted the regionalism approach to greenways.

Motion was made by Commissioner Carly Cooke, and seconded by Commissioner Mary Beth Murphy, to authorize the County to enter into an Interlocal Agreement, in substantial form, with the Piedmont Triad Regional Council to administer a \$500,000 award from the Great Trails State Program for the development of the Piedmont Regional Greenway. Amend the Trails Development capital project ordinance to reduce the appropriation to the project by \$130,000 and reduce Other Revenue (Bond Proceeds) by \$130,000 and adopt a grant project ordinance in the amount of \$130,000 with \$130,000 in Other Revenue (Bond Proceeds).

C. 2026-237 COUNTY MANAGER'S FY 2026-27 BUDGET MESSAGE

Receive the County Manager's FY 2026-27 budget message, to be filed with the Clerk to Board for public inspection, and schedule a public hearing on the Manager's FY 2026-27 Recommended Budget and proposed economic development incentive grants for June 4, 2026 at 5:30PM in the Commissioners Chamber, located on the second floor of the Old County Courthouse, 301 W. Market Street, Greensboro, NC.

Chairman Alston recognized County Manager Victor Isler.

Manager Isler shared that it is a great honor to be here to share the Manager's Recommended Budget. He reviewed the standards used to design this year's budget. He noted that this budget preserves fund balance, maintains employer competitiveness, sustains a multi-year capital plan, and sustains the school capital debt services plans.

Manager Isler noted that the revaluation of properties has created understandable concerns. He noted that the recommended property tax rate is 61.9 cents, the lowest property tax rate in over 20 years. He noted that this recommendation is responsible and above the revenue-neutral rate to maintain services.

Manager Isler noted that the recommended tax rate provides operating support for core services, county capital needs, strategic priorities, and K-12 funding for operations and debt services. He noted that the proposed budget recognizes cost of living and inflation, navigating the loss of federal and state revenues, compounded capital expenses, public safety, and health-related positions. He shared how the proposal addresses housing, homelessness, and advances our fire rescue goals.

Manager Isler shared that Guilford County is growing, as we are one of the largest counties in the state. He explained that we have grown 5% since 2020 and are projected to add 86K residents in the next 20 years, as a result of our economic development success.

Manager Isler emphasized that Guilford County is truly at the center of it all, with more than 138K people flowing into Guilford County each day, which increases service demand. He noted that Guilford County's growth requires infrastructure, workforce skill development, housing, and service capacity. He shared that our budget must strategically align with this context.

Manager Isler explained that growth means that we need to have a clear framework. He noted that we have a very uncertain economy. He urged consideration that economic distress increased the demand for safety nets and economic services. He shared that residents have clearly expressed that inflation is impacting their daily lives.

Manager Isler noted that Guilford County shows up in times of need. He reviewed examples of cross-system collaboration, such as the Adult Resource Team, The One Guilford Support our Pantries Program, and data intelligence work that we are using to guide resident engagement based on high utilization of services.

Manager Isler noted that Guilford County has the third-highest poverty rate at over 30%. He shared that low wealth has a direct and measurable impact on public education at the local level. He highlighted that 65% of schools are designated as Title 1; a higher concentration than other peer jurisdictions.

Manager Isler emphasized thinking about the fiscal health in building a budget, which means we must have strong debt ratios and structurally balanced budgets. He noted that Guilford County is financially well-managed, as we maintain the highest credit rating on outstanding general obligation debt.

Manager Isler shared that the debt to assessed value measure shows that our existing and proposed debt remains well below both the state cap and the County's more restrictive policy. He noted that his budget recommends a reduction in the use of fund balance.

Manager Isler noted that our revenue outlook outlines the county's revenue sources. He shared that budget projects show \$13M of natural recurring growth. He shared that as we look at sales tax, growth has slowed over the last few years. He explained that we are looking at a 0% growth over the prior year budget to next year.

Manager Isler shared that federal and state revenues are also constrained. He noted that the implementation of HR-1 has reduced the federal cost share for food and nutrition services from 50% to 25%, a \$3.1M shortfall. He noted that the budget reduces the appropriated fund balance by \$7.8M, ensuring the county has sufficient unassigned reserves to weather changes in federal funding or economic shocks. He noted that the County has increased public school funding at a rate greater than the state.

Manager Isler noted items in the continuation budget, including Jail Medical Services, Foster Care Room and Board, prioritized mandates, and Board commitments. He noted the mandated services, which represent 86% of the county's services.

Manager Isler reviewed the County's key investments in core services. He noted that we must plan for our future growth. He explained that for rural fire districts, this budget caps their budgets at 16% above revenue neutral as responsible measures to limit the burden placed on property owners.

Manager Isler reviewed additional positions included in his recommended budget. He noted that the budget adds capacity in the County Attorney's Office, Information Technology, Human Resources, County Administration, and the Budget team. He spoke to funding technology modernization. He noted that the budget offers an additional \$1M to enhance street outreach and emergency sheltering, while continuing eviction mediation and landlord engagement programs with an additional \$0.4 million in county funds.

Manager Isler noted that several requested positions and enhancements are not included in the recommended budget: (1) 51 positions requested by county departments are not funded including Clerk's Office, Information Technology, Sheriff's Office, Veteran's Services, Planning and Development, Tax, Social Services, Family Justice Center, and Public Health, (2) \$6.2M in additional operating funding, (3) \$9.6M in additional vehicle funding requests from Emergency Services and Sheriff's Office, and (4) \$2.6M in additional opportunities to enhance technology infrastructure.

Manager Isler shared that the County has funded the construction of over 20 schools and provided school safety and security improvements across all schools. He noted that Guilford County continues to demonstrate an impactful local funding effort, fostering positive outcomes by ranking in the top 10 school districts statewide in key areas: 5th in principal supplements, 3rd in assistant principal supplements, and 9th statewide in calculated level of funding effort based on population demographics and level of social service supports provided. He emphasized that teacher supplements rank 23rd.

Manager Isler shared that the budget offers a 2.8% increase for local current operating, \$9M in recurring funding to fund a 5-year phased pay plan for classified staff, \$1.8M in recurring funding for safety and security enhancements, \$5M for one-to-one technology, and \$1.3M for non-bond eligible capital needs, specifically activity buses.

Manager Isler noted that this budget addresses the Board's established funding priorities. He noted that when we look at the total budget of \$925,455,000, it checks all the essential, community, and strategic investment boxes.

Manager Isler shared his recommended property tax rate of 61.9 cents. He emphasized that the county would continue to meet its core responsibilities. He noted the impact of the property tax moratorium by identifying Senate Bill 889, which was recently approved by the NC Senate and has moved to the House. He explained that Guilford County would be impacted if a moratorium were imposed: (1) No new funding for GCS, (2) Limited school capital debt service capacity, (3) No merit or compensation adjustments for county staff, (4) Flat rural fire district tax rates, and (5) Revisions to future economic incentive participation. He urged consideration to recognize that the trade-offs regarding revenue restrictions are real and must be considered.

Manager Isler advised that the public hearing is scheduled for June 4th.

Manager Isler expressed appreciation to the Board, county staff, community partners, school and college leadership, and residents who contributed to this process. He stated that I am proud to serve as County Manager and proud to work with this Board as we are moving forward.

IX. HEALTH AND HUMAN SERVICES UPDATE

Public Health Director Courtney McFadden noted the purpose and role of the Child Fatality Prevention Team. She noted that this team was established in accordance with NC General Statute §7B-1406.5.

Director McFadden noted that preliminary data is provided by the state: 2024 numbers were 73 total deaths in Guilford County. She noted the preliminary data on the 2024 leading causes of child deaths.

Social Services Director Sharon Barlow noted prevention recommendations such as strengthening systems, supporting early and continuous prenatal care, and safe sleep education. She noted that they hope to continue to purchase safe sleep equipment such as pack and plays and cribs.

Commissioner Jones thanked staff for the somber reminder that not all of our children make it through childhood. He questioned if the team had identified any metrics and geographic data to help identify locations in general for those deaths to add context.

Director McFadden confirmed data collection and advised on confidentiality parameters.

Commissioner Tillman sought clarification regarding the age of the child for this data.

Director McFadden confirmed the age range of birth to 17 years.
