

**MINUTES OF BOARD OF COUNTY

The Board of County Commissioners met in a duly noticed regular meeting on June 2, 2016 at 5:30PM, in the Commissioners' Meeting Room, 301 W. Market St., Greensboro; North Carolina.

I. INVOCATION

Board Chaplin, Ben Chavis, provided the invocation.

II. PLEDGE OF ALLEGIANCE

Chairman Phillips led those present in reciting the Pledge of Allegiance.

III. WELCOME AND CALL TO ORDER

Chairman Phillips welcomed those present and called the meeting to order at 5:40PM. He referenced the addendum to the meeting to remove the public hearing on a rezoning appeal, and to add the sale of surplus property. He noted speakers from the floor had been moved to the end of the agenda.

Through general consensus, the Board accepted the amendments to the agenda.

PROCLAMATION DECLARING JUNE 2016 AS ELDER ABUSE AWARENESS MONTH

WHEREAS Guilford County recognizes older adults are the foundation of a prosperous and viable community; and

WHEREAS elder abuse is an ever-increasing issue in our society that crosses all cultural and socio-economic boundaries; and

WHEREAS elder abuse is often defined as ANY act that harms a senior or jeopardizes his/her health or welfare; and

WHEREAS Guilford County is dedicated to eliminating ALL incidents of neglect, exploitation and/or abuse suffered by any older adult; and

WHEREAS older adults deserve to be treated with the utmost respect and dignity to enable them to serve as leaders, mentors, advocates, volunteers and active members of our community; and

WHEREAS preventing elder abuse allows older adults to live independently, and contribute to the life and vibrancy of Guilford County.

NOW, THEREFORE, BE IT RESOLVED that the Guilford County Board of Commissioners does hereby proclaim June 2016 as Elder Abuse Awareness Month and encourages all citizens acknowledge the significance of elder abuse as a public health and human rights issue, learn how to report abuse and raise awareness, and take a stand against elder abuse, neglect and exploitation.

Jenise Davis, DHHS – DSS Aging & Adult Services Division Director, thanked the Board for taking action against elder abuse, and recognized staff from the Aging & Adult Services Division.

Commissioner Coleman thanked Mr. Bell for providing the requested information regarding the eligible households receiving these services. She questioned if the percentage of construction bids awarded to MWBE contractors.

J. Leslie Bell, Planning & Development Director, reviewed the MWBE statistics for the contractors utilized by the PTRC, and stated of the six (6) rehabilitation projects completed or under bid, one (1) has been completed by a minority contractor.

Commissioner Coleman questioned the dollar amount spent on the MWBE rehabilitation.

Bell stated he did not have the information readily available.

Commissioner Coleman requested the dollar amount spent on this one (1) project.

Bell stated he would forward the information.

Commissioner Trapp questioned asked if this was a collaborative project between Community Housing Solutions and the County.

Bell stated this project was a collaboration between the County, City of Greensboro, and PTRC.

Motion was made by Commissioner Carolyn Q. Coleman, seconded by Commissioner J. Carlvena Foster to approve a second amendment to the existing tri-party HOME Program Funds Sub-Recipient Agreement between Guilford County, the City of Greensboro, and the Piedmont Triad Regional Council (PTRC) for additional HOME allocation funding for a minimum of eight (8) additional homeowner units (outside the entitlement cities of Greensboro and High Point).

VI. PUBLIC HEARINGS

A. 2016-205 PUBLIC HEARING ON COUNTY MANAGER'S RECOMMENDED BUDGET

Hold Public Hearing, having been duly noticed pursuant to the North Carolina Budget and Fiscal Control Act, for the purpose of receiving input regarding the County Manager's recommended budget presented to the Board on May 19, 2016.

Legislation Text

Lawing reviewed the changes in the N.C. General Statutes 158-7.1 regarding the public hearing requirements for allocations to economic development appropriations. He noted the hearing on the recommended budget and economic development appropriations have been properly noticed.

Chairman Phillips reviewed the public hearing process and opened the floor for the public input on the County Manager's recommended budget.

1. Brent Christensen, CEO of Greensboro Partnership, thanked the Board for their continued support of the County's economic development efforts. He spoke to the increase in collaboration and coordination between the Greensboro Economic Development Alliance (GCEDA), Greensboro Partnership and High Point Economic Development Corporation.
2. Loren Hill, president of High Point Economic Development Corporation spoke to the progress of the new Alliance and the increased communication during active projects. He shared they are proud of what the County's funding has allowed the Alliance to accomplish for the community.

3. Susan Tysinger, president of Page High School Alumni Association discussed the need to complete school capital improvement projects, and spoke to fund-raising efforts to rehabilitate the Page High School Auditorium. She urged the Commissioners work with the Guilford County Board of Education (BOE) to issue bonds, raise taxes or do whatever is necessary to rehabilitate Page High School.
4. Joe Stafford, Greensboro resident, shared the historic reputation of Guilford County Schools (GCS) and expressed his dismay that the system no longer provides textbooks. He urged the Board to fully fund the GCS request, or consider reducing the number of School Resource Officers to allow room in the budget for additional school expenses.
5. June Regan, Chairman of Partners in Public Health, spoke in support of hiring more school nurses. She shared school nursing has become more complex and demanding, due to a rise in mental health conditions, social problems and students with severe allergies, obesity, and diabetes. Regan shared the County provides only 32 nurses for 125 schools and noted each nurse services approximately 2,200 students each. She noted the critical role of the nurse as a case manager between the school and home.
6. Jennifer Noble, local attorney, spoke in support of fully funding the GCS BOE request. She reviewed the assessment by outside auditors of GCS spoke to the need to maintain school excellence and fund capital needs.
7. Luther Falls, Jr., Greensboro resident, spoke in support of fully funding the GCS budget and the importance of the school's role in supporting disadvantaged students.
8. Steve Cothran, Greensboro resident, read a selection in support of the Guilford County School system.
9. Jim Donnelly, Greensboro resident, requested the Board fully fund the GCS request. He shared his experience with workforce development in Greensboro, and noted the need to utilize the K-12 system to develop a skilled workforce.
10. Mary Donaldson, GCS employee, urged the Board to fully fund the schools and spoke on behalf of the need to increase salaries for transportation drivers.
11. Shirley Burkes, Greensboro resident, urged the Board to advocate for a 3% salary raise for school support personnel.
12. Julie Peoples, co-chair of the Greensboro Faith Leaders Council, spoke to the lack of supplies within, and capital needs of, the school system. She expressed concerns with teachers and workers not receiving a fair wages and urged the Board to fully fund the GCS budget request.

13. Winston McGregor, Executive Director of the Guilford Education Alliance, opined that the Guilford County community would like to support and work with the Board to find solutions for school funding needs.
14. Michelle Ephraim, urged the Board support a 3% raise for school support personnel and spoke in support of school nutrition staff.
15. Alan Webster, GCS bus driver, spoke in support of school employee raises, and noted the steady increase in students and capital needs within the school system.
16. Kip Blakely, Greensboro resident, shared the success of the Andrews Aviation program graduates, and noted the exceptional talent of the students in the program. He shared the benefits and successes of hiring recent graduates from the program, and urged the Board to continue its support of public education. Blakely shared his support of the Say Yes initiative and reiterated his request for the Board to continue to invest in the school system.
17. JoCarolyn Wilkins, GCS employee, spoke in support of the GCS budget request. She discussed classified employees and discussed the important roles they play in the school system.
18. Jennifer Jacobs, Greensboro resident and Jones Elementary PTA president, urged the Board to fully fund the BOE's funding request. She shared the state legislated a 3% pay raise for teacher's and spoke to the approximately \$4 million shortfall between the County Manager's recommendation and the GCS budget request. She requested the Board assist Guilford County by becoming a champion for public school funding.

There being no further speakers, Chairman Phillips closed the floor for the public hearing on the County Manager's recommended budget.

Chairman Phillips opened the floor for the public hearing on proposed allocation of funds for economic development appropriations and explained the hearing process.

1. Tom Phillion thanked the Board for their support of arts programs in Guilford County and spoke to the success of bringing the National Folk Festival to Greensboro. He noted the Board's funding serves as a catalyst to recruit donations from private sources.

There being no other speakers, Chairman Phillips closed the floor for the public hearing on proposed allocation of funds for economic development appropriations.

VII. NEW BUSINESS

- A. 2016-243 SALE OF SURPLUS PROPERTY: 1300 E. COMMERCE AVENUE, HIGH POINT, NC

Approve the sale of surplus property located at 1300 E. Commerce Avenue, High Point, NC 27260 (Tax Parcel No. 174585) for \$4,600 to the current highest bidder and authorize staff to take all reasonable and necessary steps to execute the sale of the property.

Richard Mosher, Real Estate Project Manager, introduced the item and discussed the upset bid process conducted by staff.

Commissioner Foster informed the Board she was contacted by the previous owner of the property, who stated she did not understand the upset bid process. She shared the former owner stated this property is her primary residence and now has the funds to make an upset bid.

Motion made by Commissioner J. Carlvena Foster, seconded by Commissioner Ray Trapp, to deny the sale of surplus property located at 1300 E. Commerce Avenue, High Point, NC 27260 (Tax Parcel No. 174585) for \$4,600 to the current highest bidder and authorize staff to take all reasonable and necessary steps to execute the sale of the property.

Commissioner Conrad questioned if the motion could be tabled to allow the previous owner time to submit a bid, without having to start a new bid process.

County Attorney Mark Payne stated the Board must reject the bid and begin a new bid process, which would allow the former owner opportunity to submit a bid.

Commissioner Coleman questioned if the new bid was higher than the former owner's original bid.

Mosher confirmed the new bid was higher, and the bidder followed the proper steps to submit his bid.

Commissioner Coleman questioned the difference in bid amounts.

Mosher stated the current bid was \$4,600 and the former owner's original bid was approximately \$4,300. He explained the process and bid amounts related to starting a new bid process.

Commissioner Coleman questioned the total amount owed to the County.

Mosher explained the tax foreclosure process and noted the sale of the property to the County occurred in August 2015. He noted the former owner owed approximately \$4,388 in taxes.

Commissioner Cashion questioned if the former owner's bid would have covered what she owed to the County.

Mosher confirmed the bid would have covered the taxes owed on the property.

Commissioner Cashion questioned the amount of property foreclosed upon by the County that was the primary residence of the owner.

Payne stated this was the only property where the former owner confirmed this was their primary residence.

Commissioner Cashion opined this was a nominal amount of money to displace a homeowner.

Mosher commented that the former owner has multiple properties within the area.

Commissioner Foster noted the property owner stated she owned multiple properties in foreclosure, however wanted to retain this property, as it was her primary residence.

Payne clarified the County was aware she owned multiple properties going through the foreclosure process, but had just learned this property was her primary residence. He noted the foreclosure process takes year, with multiple attempts to communicate with the owner and develop plans for payment of taxes.

Commissioner Cashion expressed concerns with disparities in the foreclosure process, and questioned if the owner was aware that she may lose a new upset bid process.

Commissioner Foster shared the owner's contact with County officials during the upset bid process.

Commissioner Cashion spoke in support of the motion.

Commissioner Henning clarified the County owns the property and the former owner must enter the upset bid process to regain the property.

Payne confirmed the clarification.

Vice Chairman Branson questioned the length of time the taxes have been delinquent.

Mosher stated the taxes were last paid in 2004.

Commissioner Trapp questioned if was a safeguard in place for owner occupied homes facing foreclosure.

Lawing stated a process was developed within the past six (6) months to thoroughly vet properties that have been delinquent for a period of time.

Payne noted when delinquency has surpassed ten (10) years, the County can no longer collect taxes, which was the driver factor in this foreclosure.

Commissioner Trapp noted the need to differentiate between owner-occupied properties and those owned by corporate entities.

Mosher corrected his previous comment and noted the taxes on this property have been delinquent since 2009.

Commissioner Coleman clarified the motion on the floor and stated if the Board declined the bid, the property will be placed back on the market. She expressed her support of the motion.

Chairman Phillips questioned if the previous owner had other properties.

Mosher shared that she does own additional properties, but is unsure if those properties are in foreclosure. He shared his communications with the customer regarding the upset bid process.

Chairman Phillips questioned if the previous owner had other properties with tax delinquency.

Mosher stated he will research to determine all properties, and if there are delinquent taxes owed.

Commissioner Foster confirmed the former owner has one (1) other property with delinquent taxes owed.

Chairman Phillips questioned when the County took ownership of the property.

Mosher stated the County took ownership on August 26, 2015.

Chairman Phillips expressed concern that staff are unable to validate if the former owner still resides on the property, as the County obtained ownership in August 2015, and the length of time taken to initiate the upset bid process.

Payne stated he is unaware if the County has ever foreclosed on owner-occupied property. He noted the additional time taken to communicate with the former property owner, prior to entering the upset bid process.

Mosher stated he could not validate if the former owner resides on the property.

Chairman Phillips expressed with inconsistencies in the process, and recommended staff handle these processes more expediently. He spoke in support of the motion.

Commissioner Perdue clarified if the motion passes, a new upset bid process will begin based upon her original bid amount. He noted the upset bid can re-submit his bid.

Commissioner Henning questioned if the property is her primary residence.

Commissioner Foster stated the former owner stated this was her primary residence.

Commissioner Henning expressed his reservations with supporting the motion. He recommended tabling the motion until additional information can be provided.

The Board and staff discussed the motion on the floor.

Substitute motion was made by Commissioner Ray Trapp, seconded by Commissioner Justin Conrad, to table approval of the sale of surplus property located at 1300 E. Commerce Avenue, High Point, NC 27260 (Tax Parcel No. 174585) for \$4,600 to the current highest bidder and authorize staff to take all reasonable and necessary steps to execute the sale of the property, to allow staff time to provide additional information regarding properties owned by the current occupant.
