

**MINUTES OF BOARD OF COUNTY
COMMISSIONERS
OF GUILFORD COUNTY**

Greensboro, North Carolina
June 4, 2026

The Board of County Commissioners met in a duly noticed regular meeting on June 4, 2026 at 5:30 p.m., in the Commissioners' Meeting Room, 301 W. Market St., Greensboro; North Carolina.

PRESENT: Chairman Melvin "Skip" Alston, presiding; Vice Chairwoman J. Carlvena Foster; Commissioners Kay Cashion (via virtual communication), Brandon Gray-Hill, Carly Cooke, Mary Beth Murphy, Frankie T. Jones, Jr., Pat Tillman, and Alan Perdue.

ABSENT: None.

Virtual participation was made available to members of the public and media partners.

Chairman Alston introduced Orlando Acevedo, United States Army veteran, who would lead the Pledge of Allegiance following the invocation.

I. INVOCATION

Board Chaplain Ben Chavis offered the invocation.

II. PLEDGE OF ALLEGIANCE

Mr. Acevedo led those present in the Pledge of Allegiance.

III. WELCOME AND CALL TO ORDER

Chairman Alston welcomed those present and called the meeting to order at 5:35 p.m.

IV. SPEAKERS FROM THE FLOOR

1. Margaret Villani applauded the County Manager and his team for prioritizing county residents. She noted items laid out in the budget. She applauded the funding recommendation for the Eviction Mediation program. She urged the Commissioners to accept the Manager's Recommendation.

2. Gary Kenton, Greensboro resident, spoke to property assessment values and to basing increases on sales using ten years of data and not recent sales to build equity.
3. Gail Dunham, Summerfield resident, expressed concerns regarding the budget process held by the Town. She thanked the Board for the public records requests. She expressed concerns with the lack of collaboration with the Fire Department and the Town of Summerfield's infrastructure projects.
4. Thomas Paylor, NAACP representative, spoke in support of the Guilford Clean Power Now Committee. He noted that these initiatives improve the community and lead to meaningful and lasting impacts. He shared that on behalf of the NAACP, he spoke in support of our military veterans.
5. Mike Perdue noted that the largest number of those impacted by the tax revaluation are the poorest members of our community. He spoke to the increases in rental properties.
6. Angie Williams, Operation Xcel non-profit representative, shared that they provide after-school programming. She noted that they offer an emphasis on STEM learning. She requested that the Board continue to address public education.
7. Nikki Marin Baena expressed that as a homeowner, she supports funding investments in our public schools. She spoke in support of Jones Elementary.

Commissioner Jones read the resolution.

Dr. Wood, Jordan's mother, thanked the Board for recognizing her daughter's life and accomplishments. She explained the challenge of learning how to hold grief and gratitude at the same time. She shared her appreciation of the love shown to their family.

VII. PUBLIC HEARINGS

A. 2026-238 HOLD PUBLIC HEARING ON COUNTY MANAGER'S FY 2026-27 RECOMMENDED BUDGET

Hold a public hearing on the County Manager's FY 2026-27 Recommended Budget, including but not limited to the economic development appropriations therein. Each speaker will have two (2) minutes to address the proposed budget and the public hearing will remain open until each speaker has had the opportunity to speak.

Chairman Alston opened the public hearing for proponents and opponents to the County Manager's Recommended FY26-27 Budget, reiterating the allotted two minutes for each speaker.

1. Deanna De'Liberto, Guilford County homeowner, expressed concerns regarding the homeowner property tax rates.

2. Geoffrey Beckwith shared that Guilford County provides our family with an excellent quality of life. He spoke in support of the Manager's Recommended budget. He shared that this budget provides sufficient funding to sustain our growth. He recognized that this county is efficient as a result of its AAA bond rating.

3. Sarah Jones, resident of District 5, thanked the Board for their transparency and for keeping the community informed.

4. Joanna Pendleton, Guilford Education Alliance, spoke in support of the Manager's recommended budget. She encouraged the Board to fund the Manager's budget and use its voice to advocate for our state representatives to support our students.

5. Steve Puckett spoke in support of the Manager's recommended budget. He noted the essential services and vital programs covered in the proposed budget.

6. Guy Gunn spoke in support of approving the County Manager's budget.

7. No Speaker

8. Clara Willis Marin, Jones Elementary first grader, spoke in support of getting more money from her school.

9. Speaker shared a story expressing alternatives to political views.

10. Ingrid McCarthy expressed concerns regarding property tax increases.

11. Rachel Younger, Guilford County Resident, spoke in support of funding education.

12. Mark Cubberlany encouraged the Board to consider a revenue-neutral tax rate.

13. Sheriff Sam Page shared his attendance at the community town halls. He spoke to his concerns for property tax increases.

14. Luther Falls, Jr. expressed recognition of Commissioner Cashion.

Taking a point of personal privilege, Commissioner Cashion thanked Mr. Luther for his involvement in the community.

15. Sarah Seguin spoke in support of the TEAM Clinic and Legal Support services.

16. Maliyah James, eviction court watch liaison, spoke in support of ongoing funding for the Eviction Mediation services as well as Legal Support Services.

17. Mercedes Garrett spoke in support of funding the County Manager's recommended budget and funding our education system.

18. Chris Mitchell spoke to increasing the quarter-cent sales tax to a half-cent.

19. Casey Thomas spoke in support of funding the Manager's recommended budget.
20. No Speaker
21. Tony Greeson highlighted homelessness, the farm community, and tax structures in other states.
22. Lyn McCoy spoke in support of adequately funding county services.
23. Heather Scavore urged the Board to support the County Manager's proposed tax rate. She noted that the Commissioners' efforts to provide support programs for seniors and economically disadvantaged residents.
24. Alie Rose spoke in favor of the County Manager's proposed budget.
25. Cher Bergt echoed her support of the Manager's recommended budget.
26. Kathie Harris shared her support for the County Manager's recommended budget. She noted that while it is a hardship to pay more taxes, it is a hardship she does not want to see impact on needed services.
27. Evelyn Smith shared that she is here to ask the Board to raise their taxes a moderate amount. She shared that her goal is to live in a county that is thriving. She spoke to our library system, our education programs at GTCC, and our extraordinary public safety workers.
28. Marc Powell, Julian resident, expressed concerns with rising taxes and property values and the ability to pay bills.
29. Kathy Wheeler spoke to the federal revenue losses that now fall to the county.
30. Terrell Dungee spoke in support of the eviction mediation program.
31. Lisa Randall expressed concern regarding her home appraisal.
32. Lewis Thibodeux expressed concerns about government spending and the impacts on those with fixed incomes. He encouraged the Board to seek cuts to relieve the burden on taxpayers.
33. Kierra Sattler spoke in support of the Manager's budget and funding for education.
34. Melissa Zacharias spoke to fire protection needs and funding of our TEAMS program supporting eviction mediation to help prevent homelessness. She noted that the County offers great programs, including county parks and recreation.
35. Samantha Patina, local teacher, urged the Board to stand in the gap between kids and corporations to support education funding and the Manager's recommended budget.

36. Tessa Pendley spoke in favor of local taxes and supports funding schools locally.
37. Reverend Fritz Ritsch spoke on behalf of Keep Gate City Housed. He noted that 850 households facing eviction received positive outcomes when facing eviction due to the county's support.
38. Megan McElroy spoke in support of not going to neutral revenue. She noted that while residents do not want to pay more, we do care about prioritizing funding for students. She spoke about the ongoing funding of our education system.
39. Mike Perdue thanked our public safety workers. He voiced concerns regarding the school funding process and the eviction mediation program. He urged for no additional burdens on the taxpayers.
40. Jose Sandoval spoke in support of ongoing funding for our schools. He shared his experience where his daughter's teacher left to take a higher-paying job in another state. He noted that schools are strong economic drivers. He spoke to investments in our future and supporting education funding.
41. Janet McAuley Blue, Managing Attorney, Greensboro Office of Legal Aid of NC, spoke in support of the TEAM project and eviction mediation services. She urged the Board for their ongoing support of the program and urged them to continue to do so.
42. Liz de la Torre shared that she does not mind a modest tax increase if it results in more funding for our public schools. She asked the Board to please support a budget that funds our public schools.
43. Madison Allen spoke in support of funding our schools and that our property taxes are a way of taking care of one another. She noted that a budget is a blueprint of what we value in a community. She thanked the County for valuing education.
44. John Evans, Supervising Attorney, Housing Unit of Legal Aid of Greensboro, thanked the Board for the funding of the TEAM program to help support maintaining safe housing.

There being no further speakers, Chairman Alston closed the public hearing.

Vice Chairwoman Foster further explained that when a governing board considers a contract with a non-profit, including any award of money, Board members involved with that non-profit must recuse themselves from any deliberation and record their recusal with the Clerk. This recusal process meets the governing board members' duty to vote and the recusal procedure requirements.
