Leslie Bell, Planning Director, spoke to the before the Board was to consider setting a public hearing date for the first of two readings for May 16, 2019. He shared that the public hearing would be to consider modification to the landfill franchise agreement with A-1 Sandrocks, Inc. He noted the existing agreement was approved in October 2013, and a special use permit was approved by the Guilford County Planning Board to extend the original height of the complex, and if approved, the modification would accommodate the vertical expansion, and would extend the landfill to accommodate from 300 tons to 500 tons per day and extend the franchise term limits from ten years to the “life of site” not to exceed sixty years.

Commissioner Coleman asked the typical process to extend the “life of site” from 10 to 60 years. She clarified that there were no areas around the landfill that would prohibit homeowners from building homes.

Bell noted that in 2017 the North Carolina General Assembly approved the “life of Site” to landfills; however, stated that he did not possess the data to show the number of NC landfills that have exercised this approach.

Robin Keller, Clerk to the Board, noted that the request was to set a date for public hearing at the next applicable meeting.

Motion was made by Jeff Phillips, and seconded by Justin Conrad to approve Direct staff to notice and set date for 1st reading and public hearing at the next applicable meeting to consider A-1 Sandrocks, Inc. Construction and Demolition (C&D) Landfill franchise modification.

IX. COMMENTS FROM COUNTY MANAGER

Marty Lawing, County Manager, discussed the upcoming 2020 Census, and noted that April 2020 will be Census Day. He emphasized that timeline to prepare for the Census and discussed the process of educating and fostering community participation. He stated that North Carolina could potentially gain a seat in the U.S. House of Representatives. He stressed the importance of community participation. He shared that he will be forming a committee to inform the public and share best practices to ensure that all citizens are reached for a productive Census year. He asked the Commissioners to nominate from the Board a representative to serve on the County’s census committee.

Commissioner Coleman asked about a previous discussion concerning undocumented residents and those residents who wished to maintain anonymity from the Census.

Lawing could not provide information as to what has been done in regard to protecting undocumented residents.

Commissioner Alston asked for an update on the Cure Violence Contract. He noted that he would like to see a work session to finalize the details.

Lawing shared that staff had been working with the City of Greensboro to refine a draft among the Cities and the County.

Mark Payne, County Attorney, noted that drafts have been passed between the City and the County, and they were very near to reaching a final contract.

Commissioner Coleman asked about the insurance issue with the schools.

Lawing noted that it would be discussed in Closed Session.

X. COMMENTS FROM COMMISSIONERS

Commissioner Conrad thanked the Board for the school security bond and noted that he had read about school violence approaching more than 200 school shooting incidents since the 2012 Sandy Hook incident. He thanked the school administration for their willingness and support. He spoke to prom season and encouraged all the people attending prom make safe and intelligent choices. He noted the *Reeling for Research* and the Libby Hill Oyster bake. He thanked Chairman Branson and Vice Chairman Phillips for their donations.

Commissioner Foster congratulated five Guilford County School students for receiving scholarships to attend High Point University.

Commissioner Coleman extended her condolences to the Kilimanjaro family for their loss of Dr. John Marshall Kilimanjaro (né Stevenson), Sr., professor, civil rights activist, trailblazing newspaper founder and publisher passed away on Wednesday, March 27, 2019 in High Point, N.C.

Vice Chairman Phillips shared his attendance of the EMS groundbreaking last Friday. He thanked all personnel for their continued efforts to keep Guilford County safe. He stated that the new facility slated to open next year will provide for more efficiency to maintain equipment and ensure speedy response times.

Chairman Branson extended thoughts and prayer to Commissioner Cashion and shared details about her condition, and wished her a speedy recovery.
