

**MINUTES OF BOARD OF COUNTY
COMMISSIONERS
OF GUILFORD COUNTY**

Greensboro, North Carolina
June 5, 2025

The Board of County Commissioners met in a duly noticed regular meeting on June 5, 2025 at 5:30 p.m., in the Commissioners' Meeting Room, 301 W. Market St., Greensboro, North Carolina.

PRESENT: Chairman Melvin "Skip" Alston, presiding; Vice Chairwoman J. Carlvena Foster; Commissioners Kay Cashion, Brandon Gray-Hill, Carly Cooke, Mary Beth Murphy, Frankie T. Jones, Jr., Pat Tillman, and Alan Perdue.

ABSENT: None.

Virtual participation was made available to members of the public and media partners.

Chairman Alston introduced Jimmie Pegram, United States Air Force veteran, who would lead the Pledge of Allegiance following the invocation.

I. INVOCATION

Board Chaplain Ben Chavis offered the invocation.

II. PLEDGE OF ALLEGIANCE

Mr. Pegram led those present in the Pledge of Allegiance.

III. WELCOME AND CALL TO ORDER

Chairman Alston welcomed those present and called the meeting to order at 5:39 p.m.

IV. SPEAKERS FROM THE FLOOR

1. Gail Dunham, Summerfield resident, expressed concerns with the use of American Rescue Plan Act (ARPA) funding for town water resources. She noted that her daughter, Gretchen Green, is now the 102nd female astronaut in the country's history.

2. E. Hollingswood expressed concerns with an overpayment to the Guilford County Tax Department.

3. Lisa McMillan, Turning Everything Around Executive Director, thanked the Board for awarding it Community-Based Organization (CBO) funding. She expressed appreciation for Debra Mack and the Mental Health initiatives being introduced throughout the County. She shared personal experiences and noted that staff provided information on resources and verbiage to use when seeking those resources. She spoke to the impact of Mack's recent presentation on suicide awareness and her personal experience with the topic.

4. Marcus Shields, Children's Law Center, spoke to the center as a resource for children in the judicial system and thanked the Board for its support during the prior year. He spoke to the silent threat of domestic violence (DV) and reiterated his appreciation for the Board's support.

5. Aidan Loretz, Haw River Assembly, provided an overview of the organization's efforts related to the Southeast Supply Enhancement Pipeline (SSEP) over the past few months. He noted 224 Oak Ridge residents have signed a petition in opposition to the Transco pipeline. He urged the Board to request a more thorough environmental impact statement.

6. Scott Jones, Tiny House Community Development Executive Director, thanked the Board for allowing him to speak with the Homelessness Taskforce. He shared that they are in the process of completing a veterans-only tiny home community and invited the Board to visit the site to view the progress. He spoke to the need for additional funding to build respite care housing for veterans. He shared that they will offer a construction certification program for 15-18-year-olds this summer. He shared the housing project address in High Point is 507 Smith Street.

7. Jason Hicks spoke to the County's termination of the contract with Samet Corporation and noted the reason has not been shared with the public. He requested the County share the reason for termination.

8. Tessa Pendley, Guilford County Association of Educators (GCAE) member, shared that they are delivering handwritten letters from the community regarding this year's budget.

Chairman Alston noted that Commissioner Murphy did distribute the letters to the Board.

9. Iris Sunshine, Children's Law Center of Central NC Executive Director, thanked the Board for supporting the center. She shared that they are celebrating their 20th year of advocacy and noted the Board's continued investment will help the center continue to positively impact the lives of children that need their assistance. She shared that they were a founding partner of the Family Justice Center (FJC) and Camp HOPE and spoke to the transformational nature of these programs.

V. PRESENTATIONS

- A. 2025-286 RESOLUTION HONORING REVEREND CARL VIERLING AND THE GREATER HIGH POINT FOOD ALLIANCE

Vice Chairwoman Foster shared her honor to present the resolution to Reverend Carl Vierling, his wife Lisa, and members of the Greater High Point Food Alliance (GHPFA). She read the resolution into the minutes.

Rev. Vierling thanked the Board for the recognition and noted that, ten (10) years ago this month, the Greensboro-High Point area was recognized as one of the largest food deserts in the nation. He spoke to the importance of everyone working together to address community challenges. He shared the citizens are the greatest power Guilford County has today and shared it was this spirit that created the GHPFA. He noted no other community in the state had greater improvements in a shorter period of time than Greensboro-High Point with regards to food deserts.

Commissioner Gray-Hill thanked Development Manager Nathan Crabtree and the Guilford Green Foundation for their work in the community and invited them to receive the resolution. He spoke to Guilford County's advocacy for the rights of all and shared members of the Lesbian, Gay, Bisexual, Transgender, Queer or Questioning (LGBTQ) community are valued. He read the resolution into the minutes.

Crabtree thanked the Board for the resolution and shared that Guilford Green is the longest-running LGBTQ center in the Southeast United States. He noted they provide referrals and information for members of their community and noted PRIDE is not only a celebration, but also a commemoration of where they have been, where they are, and where they're headed.

Interim Public Health Director Anita Ramachandran thanked the Board for its recognition of Gun Violence Awareness Month. She introduced Health Educator Alexis Powell, who would provide an update on current Public Health activities and community outreach currently underway.

Powell discussed the social determinants of health and the benefits of utilizing these with health education. She discussed the decrease in firearm-related homicides and spoke to the importance of community-driven collective action to continue decreasing injuries and homicides.

VII. PUBLIC HEARINGS

- A. 2025-280 HOLD PUBLIC HEARING ON COUNTY MANAGER'S FY 2025-2026 RECOMMENDED BUDGET

Hold a public hearing on the County Manager's FY 2025-2026 Recommended Budget, including but not limited to the economic development appropriations therein. Each

speaker will have two (2) minutes to address the proposed budget and the public hearing will remain open until each speaker has had the opportunity to speak.

Legislation Text

Chairman Alston reminded the public of the rules and procedures for the public hearing and opened the floor for the hearing.

1. David Coates, Board of Education (BOE) member, spoke to the quality educational services provided by the Guilford County Schools (GCS) staff and expressed concern with the allocation of funding for GCS presented in the FY26 recommended budget.

2. Samantha Patino, high school math teacher, expressed her love for public schools and teaching. She spoke to the importance of adequate funding for the schools.

3. Brian Carter, GCS parent, spoke to the importance of parents and citizens supporting schools.

4. Karrie Parrish, parent and Guilford For All member, expressed her concern for the future of public education in Guilford County. She spoke to teacher salaries, incongruent with Board values, and the importance of offering a livable wage.

5. Sarah Jones, Greensboro resident and educator, requested the Board raise taxes in order to fund schools. She shared her experience of moving to Guilford in 2003 because of a livable wage and excellent public schools. She spoke to the investments in infrastructure and encouraged the Board to invest in people.

6. Miles Kirkpatrick, Guilford County resident, spoke to the importance of the Board supporting GCS. He noted that underfunded schools and staff are an emergency that requires the use of savings and spoke to the importance of identifying ongoing funding to support their needs.

7. Edwena Miles, spoke to the need for additional funding to support increased salaries for educators and classified staff. She shared that students cannot afford for the Board to not support the school system.

8. Steve Pruitt, Greensboro resident, spoke to the need to provide additional funding for salaries for classified staff and discussed concerns with low staffing in certain departments.

9. Jessica Fox spoke to the factors that contribute to a successful student and shared that the number one (1) factor is an effective teacher. She expressed her concerns with being told her job is not worthy of fair compensation and urged the Board to ensure the budget includes sufficient funding for schools, teachers, and classified staff.

10. Sara Passey, parent, thanked the Board for consistently funding GCS and urged them to increase funding in the FY26 budget to align with the GCS request.

11. Tessa Pendley, District 7 resident and GCS employee, questioned the Board's why and encouraged them to ensure the budget accurately reflects the values of this community.

12. Toby Hedgepeth, GCS parent, thanked the Board for its service to Guilford County. She requested that the Board increase local funding to GCS, specifically to increase funding to support teachers and classified staff. She spoke to the impact of increased salaries for educators and support staff and how it affects the community.

13. Michael Mann expressed concern with the significant increase in funding for charter schools included in the FY26 recommended budget. He spoke to education as a generational investment and encouraged the Board to increase funding for public schools.

14. Rondeshia Wallace, Peck Elementary cafeteria manager, spoke to the importance of fully funding the GCS request in the county's FY26 recommended budget. She expressed concern regarding the funding included in the recommended budget.

15. Sonya McTillman, GCS teacher, spoke to the impact of the recommended budget on teachers and classified staff. She expressed concerns with the lack of funding included for body scanners in the schools.

16. No show

17. Jason Hicks thanked the Board for not funding Downtown Greensboro, Inc. (DGI) and encouraged the Board to not fund any organization associated with DGI in the recommended budget.

18. Ebony Burnett, District 4 resident, shared a recent experience at a school function and spoke to the importance of metal detectors and body scanners throughout the school system. She spoke to the importance of prioritizing safety within the schools and supporting teachers and classified staff.

19. Annabel Hrubes, GCS teacher, shared her salary is not sufficient for the rising cost of living. She spoke to concerns with having to give up her current profession to make ends meet and spoke to a recent experience with a student who previously attended a charter school. She encouraged the Board to require charter schools to meet the same standards abided by public schools.

20. Yolanda Lucas, GCS employee, expressed concerns with proposed budget cuts and the impending loss of her position as a result. She spoke to the impact of these budget cuts upon students, teachers, and classified staff.

21. Reverend Fritz Ritsch, Greensboro resident, thanked the Board for funding the Tenant Education Advocacy Mediation (TEAM) project. He shared the purpose of the program and noted eviction impacts a person's ability to secure future housing and requires local government to utilize funding to support the unhoused. He requested the Board commit \$844,000 to the project to support full-time work.

22. Brian Spurlock, District 2 resident, spoke to the importance of ensuring local public schools will be safe places for his children, along with ensuring educators and classified staff will make a

livable wage. He encouraged the Board to remember that Guilford is a place where we take care of each other.

23. Ryan Creekmore, member of Guilford For All, encouraged the Board to redirect funds to fully support GCS. He discussed staffing shortages as a result of these budget shortfalls and concerns with students not learning at grade level. He spoke to the importance of identifying solutions to ensure student success.

24. No show

25. Renee Norris, program coordinator for the University of North Carolina at Greensboro's (UNCG's) Center for Housing & Community Studies and discussed what has been accomplished as a result of the County's investment in the TEAM project. She shared their work with landlords and tenants.

26. Terrell Dungee, TEAM tenant representative, thanked the Board for its support of the program and encouraged the Board to continue its support for a fifth year. He spoke to their ability to identify more affordable housing properties that have been neglected and their work with tenants and landlords to make upgrades.

27. Joanna Pendleton, public school librarian and GCAE president, discussed their recent rally. She requested the Board prioritize GCS in the FY26 recommended budget. She noted the community values public education and called upon the Board to do the same in the budget.

28. Anita Washington, Greensboro resident, shared that she was a TEAM Tenant volunteer and spoke to her lived experience with the program. She discussed the impact of the program and urged the Board to continue its support of the program.

29. Attorney Janet McCauley Blue, Legal Aid NC, spoke to the TEAM Tenant project as a collaboration between Legal Aid and UNCG. She thanked the Board for funding the project and spoke to the tenants who have been protected over the prior four (4) years. She discussed how the program works and noted that without County funding, they will not be able to continue the program.

Following the last person who signed up to speak, Chairman Alston opened the floor for any additional speakers to address the FY25-26 recommended budget.

Jim Doermann, Greensboro resident and criminal defense attorney, spoke to the impact of the County budget on housing, which further impacts crime rates. He shared the budget is a reflection of community values and spoke the importance of supporting children.

Cecily Crawford, Keep Gate City Housed Coalition, spoke to her own eviction experience and shared the experiences she has observed as a member of TEAM Tenant. She discussed how the program benefits clients and shared how these programs save counties funding. She encouraged the Board to fully fund the program.

Devon Brascoe, North Carolina A&T State University graduate and member of Keep Gate City Housed Coalition, shared her experience with the TEAM Tenant program. She thanked the Board for its support and urged them to continue funding the program to ensure those facing eviction receive the help they need.

Michael Cheema, Legal Aid attorney, expressed his honor to serve those facing eviction. He expressed the importance of fully funding the program and noted that they are only currently funded to work with clients part-time.

There being no further speakers, Chairman Alston closed the public hearing.

She shared her participation in the North Carolina Association of County Commissioners (NCACC) Board Meeting at the Hoke County Equestrian Center where they discussed upcoming events. She noted she will attend steering committees and NCACC County Advocacy Days next week. She congratulated all graduates, students, and teachers.

Commissioner Cashion shared her participation the National Association of Counties (NACo) Art & Culture Committee and Justice and Public Safety (JPS) Committee meetings.
