Thank you for your willingness to assist us with our request to continue our work with Alexander Youth Network/Youth Focus HEARTH program for the upcoming 2024-2025 fiscal year.

We are grateful for this local-state partnership and for this opportunity to present the attached program agreement to provide pertinent information to the county regarding the program. We wish to utilize our NCALLIES database as our disbursement mechanism for this program, much as we do with JCPC funded programs. Our office will be monitoring all expenditures of the program for reimbursement and payments via NCALLIES monthly disbursements. We request the county's assistance as a passthrough for monthly payments to support the HEARTH program.

As in our previous arrangement and agreement with Guilford County, the section agrees to the following:

- NCDPS will assume the responsibility for monitoring the HEARTH program's services and expenditures.
- Guilford County and JCPC will not be required to complete any program monitoring, financial reviewing or any other program review.
- Guilford County would only be a pass-through for payment of funds from NCDPS to the HEARTH Program, utilizing the NCALLIES database as the disbursement mechanism, on terms to be set out in an agreement/contract between Guilford County and Alexander Youth Network/Youth Focus for the HEARTH program. NCDPS will disburse funds to Guilford County monthly for the county to disburse to Alexander Youth Network/Youth Focus for the HEARTH program.
