FIRST AMENDED INTERLOCAL AGREEMENT

**BETWEEN THE CITY OF GREENSBORO, NC
and
THE COUNTY OF GUILFORD, NC**

FY 24-25 HOMELESSNESS PREVENTION GRANT

Amount -- \$45,000.00 (No Matching Funds Required)

Award Date – July 16, 2024; Original Grant Period – July 1, 2024 to June 30, 2025

THIS FIRST AMENDED INTERLOCAL AGREEMENT (hereinafter “AMENDED AGREEMENT”) is entered into effective June 30, 2025 and amends the original INTERLOCAL AGREEMENT that was effective the 1st day of July, 2024 by and between, the CITY OF GREENSBORO, Guilford County, North Carolina (“the CITY”), acting by and through its governing body, the Greensboro City Council; and GUILFORD COUNTY, North Carolina, (“the COUNTY”) acting by and through its governing body, the Guilford County Board of Commissioners on behalf of the Guilford County Sheriff’s Office (“GCSO”) and the GCSO’s Re-entry Program. The CITY and COUNTY will sometimes be referred to collectively herein as the “PARTIES”.

W I T N E S S E T H :

WHEREAS, the sixth paragraph in the Recitals section of the PARTIES’ original Interlocal Agreement entered into on or about July 1, 2024, specified a performance period from July 1, 2024 through June 30, 2025. That original Interlocal Agreement has been complied with by both parties in all respects but requires an amendment to allow the COUNTY additional time to seek reimbursement for housing-related funds awarded to the COUNTY by the CITY under the original Interlocal Agreement and spent by the COUNTY (with the CITY’s authorization) between June 30, 2025 and September 30, 2025.

WHEREAS, for the purpose stated in the preceding paragraph, the PARTIES mutually desire to extend the term of the original Interlocal Agreement by three (3) months from July 1, 2024 through June 30, 2025 to July 1, 2024 through September 30, 2025;

NOW, THEREFORE, in further consideration of the covenants and representations contained herein and in their original Interlocal Agreement, the PARTIES agree to amend the sixth paragraph in the Recitals Section of the original Interlocal Agreement as set forth in the italicized passage which follows:

***WHEREAS**, on July 16, 2024, the CITY (as primary Recipient) awarded the COUNTY (as Subrecipient on behalf of the GCSO and the GCSO's Re-entry Program) the sum of **FORTY-FIVE THOUSAND (\$45,000.00) DOLLARS** in funding from the GRANT to be used during the GRANT period of July 1, 2024 to September 30, 2025. . .*

THE PARTIES agree that all other terms and conditions of the original Interlocal Agreement entered into on or about July 1, 2024, **SHALL REMAIN THE SAME**.
