Dear Manager Lawing:

As we discussed in our telephone conversation on Tuesday, the Nussbaum Center for Entrepreneurship (Nussbaum Center) formally requests forgiveness of the loan provided to the Nussbaum Center by Guilford County by notes or other documents dated March 22, 2001 and amended on March 4, 2011 and October 21, 2014.

The proceeds of this loan were used to renovate the third-floor expansion of our operations then located at Revolution Mill which was prior to my becoming CEO of the organization. The Nussbaum Center had to relocate from the Revolution Mill facility due to circumstances beyond our control to our present facility which was donated by an entity owned by D. H. Griffin, David Griffin and Jimmy Clark.

Repayment of this loan at this time will cause substantial hardship for the Nussbaum Center and would leave the Nussbaum Center with little or no reserves available to it to operate or manage unbudgeted and/or unexpected expenses.

As I mentioned in our conversation, the Nussbaum Center has provided and continues to provide significant benefit to Guilford County and surrounding areas. These benefits include the creation of wealth and above average jobs which our community desperately needs.

This compares to just under 11% of North Carolina businesses being minority or women owned businesses according to US Department of Commerce.

The Nussbaum Center spent \$3,000,000 renovating the old Carolina Steel building located at 1451 S Elm Eugene Street at the intersection of Florida Street which was underutilized and at risk of being torn down. We now use the building for our small business incubator. With over 200 people entering the building every day, we are changing the perception of South Elm Eugene as a safe place to do business.

The forgiveness of the loan established by prior administrations of both Guilford County and the Nussbaum Center will be of substantial benefit to our organization. Forgiveness will allow our two person staff the ability to stay focused on the creation of wealth and better than average paying jobs for our community. We feel that our request is a fiscally sound decision based on the historical contribution that our organization has made consistently over 30 years with regard to job creation and investment in the County.

### GUILFORD COUNTY CONTRACT NO. 36474-03/01-182, AMENDMENT NO. 2 THE NUSSBAUM CENTER FOR ENTREPRENEURSHIP, INC.

# STATE OF NORTH CAROLINA COUNTY OF GUILFORD

THIS CONTRACT is hereby made, entered into, and effective as of this 18th day of September, 2014, by and between **GUILFORD COUNTY**, a body politic and corporate of the State of North Carolina, hereinafter referred to as the "COUNTY," and **THE NUSSBAUM CENTER FOR ENTREPRENEURSHIP, INC.**, a non-profit corporation organized under the laws of the State of North Carolina, hereinafter referred to as the "CENTER," and also collectively referred to as the "Parties."

#### WITNESSETH:

WHEREAS, the Parties entered into a CONTRACT on March 22, 2001, and amended it on March 4, 2011, whereby the COUNTY granted a loan in the amount of \$75,000.00 to the CENTER for the exclusive purpose of expanding its facility, which is now located on South Elm-Eugene Street in Greensboro, NC, and enabling the CENTER to better assist in the creation of small businesses, economic activity, employment opportunities, and tax base; and,

WHEREAS, the CENTER has requested and the COUNTY has agreed to amend the terms and extend the term of the initial Contract.

NOW, THEREFORE, in consideration of promises mutually exchanged, the Parties mutually agree to the following changes are hereby made to the initial Contract as follows:

- 1. The loan repayment period is hereby extended from March 31, 2014 to March 30, 2017, at which time a lump sum repayment will be made to the COUNTY by the CENTER in full without demand.
- 2. The audit requirement in paragraph 4 of the initial Contract is hereby removed.
- 3. The Parties agree that this Contract is subject to the jurisdiction and laws of the State of North Carolina. The CONTRACTOR will comply with bid restrictions, if any, and applicable laws, including N.C.G.S. §143-129(j) regarding E-Verify. Any controversies arising out of this Contract shall be governed by and construed in accordance with the laws of the State of North Carolina.

All other provisions of the initial Contract, as amended, are hereby ratified and shall continue in full force and effect without change, unless and until revised upon mutual written Agreement of the Parties, or terminated as provided herein.
