B. 2025-405 PUBLIC HEARING ON FY 2026-27 5310 ENHANCED MOBILITY FOR

SENIORS AND INDIVIDUALS WITH DISABILITIES GRANT APPLICATION AND APPROVAL OF APPLICATION

Background: The Guilford County Transportation Department has prepared the

5310 - Enhanced Mobility for Seniors and Individuals with

Disabilities to be submitted to the North Carolina Department of Transportation / Integrated Mobility Department (NCDOT/IMD) in October 2025. The total amount of the 5310 grant request for FY 2026-27 is \$250,000, with 50% or \$125,000 in Federal funding and 50% or \$125,000 in County match funding, which will be used for departmental salaries and vehicle maintenance expenses. Staff projects that these funds will support 10,902 trips in FY 2026-27. The FY 2025-26 grant was in the total amount of \$250,000 with \$125,000 in Federal funds and \$125,000 in County match.

A public hearing is required to assess the value and need for a community transportation system and assistance to the elderly and disabled citizens of Guilford County. Attached is a summary of the grant request and authorizing resolution.

TRANSPORTATION ADMINISTRATION GRANT APPLICATION AND

Background: The Guilford County Transportation Department has prepared the

5311 - Community Transportation Program grant application to be submitted to the North Carolina Department of Transportation / Integrated Mobility Department (NCDOT/IMD) in October 2025. The total amount of the 5311 grant request for FY 2026-27 is \$320,646, with 85% or \$272,548 in Federal and State funding and 15% or \$48,098 in County match funding, which will be used for administrative and capital expenses. The FY 2025-26 grant was in the total amount of \$316,454, with \$268,985 in Federal and State

funding and \$47,469 in County match funds.

A public hearing is required to assess the value and need for a community transportation system and assistance to the elderly and disabled citizens of Guilford County. Attached is a summary of the

GUILFORD COUNTY SCHOOLS (GCS) CAPITAL PROJECT AMENDMENTS: CAPITAL RENOVATIONS

Background:

Guilford County voters have approved a total of \$2.0 billion in school bond referendums to address school capital needs identified through a comprehensive facilities master plan jointly developed by the Guilford County Board of Education and Guilford County Board of Commissioners. The funding plan calls for \$500 million to address deferred capital renovations to support addressing needs at every school across the county.

On September 9, 2025, the Guilford County Schools Board of Education (BOE) approved realigning remaining funds from completed or closed projects, totaling \$3,585,974. These projects included Brooks Global Studies and Claxton Elementary, and prior budgeted funds for Cone Elementary and Florence Elementary. The Board of Education approved utilizing those funds to expand renovation efforts at Dudley High School, District-Wide Projects, Fairview Elementary, Kernodle Middle, Oak Hill Elementary, Southern High School, Southwest Elementary, Southwest High School, and Western High School.

Requested Action:

Consider request from Guilford County School's Board of Education to amend capital project ordinances and if approved, authorize staff to take any and all necessary actions to amend project ordinances or adopt necessary project ordinances; and approve associated budget amendments.
