School Capital Outlay Projects Summary- September 4, 2025

Amending five (5) school capital projects funded by General Obligation bonds

At the April 15, 2021, Board of County Commissioner's work session, the Board approved projects and a plan to issue \$300 million in General Obligation bonds to fund 10 school capital projects. On May 17, 2022 the voters of Guilford County approved a \$1.7 billion bond referendum to pay capital costs of providing school facilities, including the acquisition and construction of new school facilities, the improvement and expansion of existing school facilities and the acquisition and installation of furnishings and equipment and the acquisition of interests in real property required therefore.

This item decreases one capital project, Washington Elementary, as the Board of Education has voted to close the school at the end of the 2025-2026 school year. The BOE has recommended that the \$3,845,150 previously allocated to Washington Elementary be reallocated to Page High School, Southwest Elementary, Penn Griffin School of the Arts and Fairview Elementary. The board previously adopted \$300 million in school capital projects associated with the combined \$2 billion in voterapproved GO bond debt. This has a net \$0 change, maintaining the \$699,482,077 million total in adopted projects. The subsequent Capital Project Ordinances amend the following projects in the School Capital Outlay fund:
