4. [2025-298](#) INTERLOCAL AGREEMENT WITH CITY OF HIGH POINT FOR BICENTENNIAL GREENWAY REPAIRS PROJECT

Background: The Guilford County Board of Commissioners adopted legislation to develop the Bicentennial Greenway in 1987, a 14.5 mile thoroughfare spanning four (4) county districts. The greenway serves as a transportation and recreational resource for residents and visitors, further enhancing Guilford County's appeal as a residential and professional destination.

Approximately seven (7) miles of the greenway is located between the Piedmont Environment Center and Highway 68 in the city of High Point. A portion of this section, located between Regency Drive and Piedmont Parkway, is in need of repair to: remove the existing wood walkway; install a 48" culvert pipe and stone for trench stabilization and pipe bedding; and install a new asphalt path. Given its multi-jurisdictional nature, the County would like to enter into an interlocal agreement with High Point to cover half the total amount of repair costs, in an amount not to exceed \$32,500. The city of High Point will be responsible for managing all aspects of the repairs and for administration of the construction contract.

Requested Action: Approve an interlocal agreement, in substantial form, with the City of High Point for repairs of a portion of the Bicentennial Greenway between Regency Drive and Piedmont Parkway in an amount not too exceed \$32,500.

3. [2025-317](#) OFFICE ON VIOLENCE AGAINST WOMEN (OVW) FY 25 LOCAL LAW ENFORCEMENT GRANTS FOR ENFORCEMENT OF CYBERCRIMES PROGRAM

Background:

The Office on Violence Against Women (OVW) Local Law Enforcement Cybercrimes Enforcement Program supports efforts to prevent, enforce, and prosecute cybercrimes against individuals with a focus on adult and young adult cybercrimes victims. These crimes are defined as criminal offenses which involve the use of an electronic device to harass, threaten, stalk, extort, coerce, cause fear to, or intimidate an individual, or without consent distribute intimate images of an adult.

The Guilford County Sheriff's Office would like to request funding through the grant application process to assist in the following areas:

- 1.) Training for local law enforcement personnel relating to cybercrimes.
- 2.) Educating the Public in order to prevent, deter, and identify violations of the law.
- 3.) Acquire computer equipment, and other equipment necessary to conduct investigations and forensic analysis of evidence in matters involving cybercrimes.

The projected request of the grant will be \$700,000. If awarded the grant, the funds will be used over a 36-month period, and the dates will range from October 1, 2025 through September 30, 2028.

Requested Action: Approve the Guilford County Sheriff's Office to apply for the OVW FY 25 Local Law Enforcement Grants For Enforcement Of Cybercrimes Program in an amount of \$700,000.

PUBLIC HEARING FOR CONSIDERATION OF AN ECONOMIC DEVELOPMENT INCENTIVE GRANT FOR PROJECT GAMBLE

Background:

Pursuant to N.C.G.S 158-7.1, the Board of Commissioners will hold a public hearing to receive public input on the proposed allocation funds for an Economic Development Incentive Grant to:

Cascade Die Casting Group, Inc. (aka: Project Gamble), in the amount of approximately \$57,284. The County would fund incentive payments with available revenues in the County's General Fund. The company is considering an expansion at 1800 Albertson Road, in addition to other options within the United States, for a projected investment of \$8,120,000 in personal property and the creation of forty-three (43) new jobs by December 31, 2029.

The Board of County Commissioners intends to consider entering into a contract; if approved the County will make cash incentive grants pursuant to the County's Economic Development Investment Guidelines. The company is also requesting state and other local incentives before making a location decision. The local approval of incentives does not commit the company to locate in North Carolina; however, the cash grants are contingent upon, among other things, the company's entry into a local economic development agreement with Guilford County containing the obligations and agreements of the company and Guilford County.

Requested Action:

Pursuant to N.C.G.S. 158-7.1, hold a public hearing and consider approval of an economic development incentive grant to Cascade Die Casting Group, Inc. in an amount not to exceed \$57,824; and upon approval, authorize staff to execute grant agreements, in accordance with terms and conditions of the proposal, consistent with the County's economic development incentive policy and North Carolina law.
