What We Have Accomplished

- ✓ Established Guilford County Transportation Work Group with crossfunctional stakeholders
- ✓ Collaborated with partners to identify key transportation challenges.
- ✓ Analyzed data shared from partner agencies
- ✓ Developed problem statements across five critical focus areas
- ✓ Generated evidence-based strategy recommendations with prioritization
- ✓ Piloted mobility solutions in identified gaps
- ✓ Created a foundation for coordinated countywide transportation planning

Core Challenges

- Current transit services limit access to transportation for employment for some shifts and large workplaces.
- Current transit services limit access to behavioral health and other resources that support vulnerable populations.
- Fleet maintenance and expansion is tied to ridership and reliable transit options.
- Connecting and enhancing regional mobility.

Five Critical Focus Areas

- 1. Workforce & Employment Employment access and job readiness
- Human Services (DSS/Justice/Homelessness) Supporting vulnerable populations
- Behavioral Health Services Meeting healthcare access needs across all hours
- 4. System Infrastructure Unified vision, data sharing, and coordination
- 5. Regional Integration Seamless connectivity between municipalities
