- 8) Provide a forum for regular communication throughout the NC-504.
- 9) Manage NC-504 HMIS, working with MCAH, the HMIS lead agency, to be compliant with HUD HMIS standards.

Specific NC-504 activities supported by the CA include coordinating CoC and ESG grant selection processes and collaborative applications; working with the local HMIS Lead to ensure timely submission of all HMIS reporting requirements (e.g., PIT, HIC, LSA, and SPM) on behalf of NC-504; delivering trainings and capacity improvement curricula for NC-504 agencies; assists in developing strategic actions and policies to further the goal of ending homelessness in the CoC; supports the committee work needed to operate various facets of NC-504; and works to expand the monitoring and evaluation of CoC, ESG, and other homeless grant programs and outcomes.

Guilford County DHHS, as CoC Lead and Collaborative Applicant, will provide additional staff, consulting services, and office space and overhead with local funds.

2. Describe the estimated schedule for the proposed activities, the management plan, and the method for assuring effective and timely completion of all work.

Guilford County DHHS, as CoC Lead and Collaborative Applicant, supports and facilitates a high-performing, effective, and efficient CoC by:

- Performing NC-504 application activities including preparing the collaborative application; supporting all NC-504 project applicants with their project applications; compiling system-wide and project-level data as needed and required; and implementing an annual project monitoring/performance review process.
- Supporting Coordinated Entry (CE) by researching best practices and assisting NC-504's CE Planning Committee in order to improve the system of entry into NC-504 services.
- Assisting with NC-504's System Performance and Evaluation Committee in establishing priorities for funding projects in NC-504, determining which applications can be received for consideration, supporting the ranking process, and selecting the applications being submitted for funding.
- Implementing System Administration and providing staff support to NC-504 and its Board of Directors, offering training and technical assistance to providers.
- Continuing the work of ending homelessness for any individuals who "age into chronicity" in order to maintain an end to homelessness in that sub-group; racial and ethnic evaluation of service delivery and underserved groups including individuals with lived experience; work with veteran service providers to decrease and eventually reach functional zero for veteran homelessness, focus efforts on ending homelessness for unaccompanied youth and families with children to end homeless in those groups according to Home, Together: The Federal Strategic Plan to Prevent and End Homelessness.
- Cementing the "relational glue" by building connections, engaging stakeholders, and keeping NC-504 focused on their mission and responsibilities.
- Monitoring and assisting organizations in meeting their individual goals in order for all to succeed as a CoC.

As a result, Guilford County DHHS as the CoC Lead will be positioned to:

- Develop strategic partnerships and innovative initiatives to address gaps in homeless services and affordable housing needs, and
- Strengthen organizational infrastructure and financial resources to support NC-504 and its members.

NC-504 is responsible for annually reviewing the performance of the Collaborative Applicant, fact finding and helping to resolve stakeholder challenges of decisions by the Collaborative Applicant, and leading the process of deciding whether to re-select the Collaborative Applicant or to undertake and facilitate a competitive process with the possible outcome of selecting a new Collaborative Applicant. The Memorandum of Understanding between NC-504 and Guilford County DHHS has an annual duration that renews automatically unless either party gives appropriate notice of termination.

# 3. How will the requested funds improve or maintain the CoC's ability to evaluate the outcome of CoC and ESG projects?

Guilford County DHHS, as CoC Lead and Collaborative Applicant, will continue to develop monitoring, measuring, and strategic collaborations as described above. A portion of Planning Grant funding will go towards a staff positions to oversee performance monitoring of CoC and ESG funding, and the Systems Performance and Evaluation Committee and NC-504 Board of Directors, assisted by Guilford County DHHS staff, will develop processes for selecting measuring, monitoring, and evaluating all projects applying for ESG and CoC funding to ensure we are continuing to efficiently and effectively reduce homelessness in Guilford County and meeting system-wide goals.
