RE: Capital Fund Transfer to Career and Technical Education ordinance, Roofing-Various Sites ordinance and System-Wide Renovations FY2012 ordinance

During its February 28, 2019 meeting, the Board of Education (BOE) approved six (6) Signature Career and Technical Education (CTE) academies as magnet options at the following schools: Academy at Smith, Kearns Academy, Northeast High School, Smith High School, Southeast High School, and Western High School. On April 30, 2019, the BOE approved a capital fund transfer in the amount of \$7,113,803; into a CTE Capital Improvements project ordinance, the Roofing-System-wide project ordinance and the System-Wide Renovation FY2012 project ordinance from the following project ordinances:

Guilford County Schools administers all educational programs, employment activities and admissions without discrimination because of race, religion, national or ethnic origin, color, age, military service, disability, marital status, parental status, or gender, except where exemption is appropriate and allowed by law.

Each project listed on the previous page is complete except High Point Central and Western Guilford Middle school for which we reserved funding for project close-out.

At the April 30, 2019, the Board of Education approved \$1,890,000 for immediate repairs that will address water intrusion concerns at Gateway Education Center to include replacement of the roof and partial repair of the windows. The remaining \$5,223,803 will provide CTE classroom and laboratory spaces necessary for the programs.

**RECOMMENDATION:** The Board of Education, by the April 30, 2019 vote, requests transferring \$5,223,803 from the capital project ordinances listed above into a CTE Capital Improvement project ordinance to fund capital improvements at new CTE signature academies, transferring \$1,600,000 from the capital project ordinances listed above into the Roofing System-wide project ordinance to fund roof repair/replacement at Gateway Education Center and \$290,000 to the System-Wide Renovation FY2012 project ordinance to fund window repairs at Gateway Education Center.

## **Potential Project Summaries**

### **Academy at Smith**

Moderate renovation to existing classrooms and lab spaces into one (1) Mental Health classroom/CTE lab, and one (1) Pharmacy Technology classroom/CTE lab

### **Kearns Academy**

Minor renovation to existing classrooms into one (1) Artificial Intelligence classroom/CTE lab, one (1) Geospatial Technologies classroom/CTE lab, and up-fit of an existing computer based classroom/CTE lab for Cyber Security program

### **Northeast High School**

Up-fit of existing classrooms into one (1) Artificial Intelligence classroom/CTE lab, one (1) Geospatial Technologies classroom/CTE lab, and one (1) Cyber Security classroom/CTE lab

### **Smith High School**

Build a new CTE building to include: one (1) Advance Manufacturing classroom/lab, one (1) Engineering classroom/lab, six (6) core classrooms, one (1) collaboration area, and faculty office space

### **Southeast High School**

Major renovation to existing CTE space into one (1) Advanced Manufacturing CTE lab and one (1) Engineering Lab

### **Western High School**

Moderate renovation of existing classrooms into one (1) Drone Technology classroom/CTE lab, as well as major renovation of an existing classroom into one (1) Diesel Technology classroom and build a new Diesel Technology Lab

### **Gateway Education Center**

Install a new roof and complete partial window replacements.
