FY2023 School Capital Outlay Projects Summary- January 05, 2023

Amending six (6) and establishing twelve (12) school capital projects funded by General Obligation bonds (\$256,340,032)

At the April 15, 2021, Board of County Commissioner's work session, the Board approved projects and a plan to issue \$300 million in General Obligation bonds to fund 10 school capital projects. On May 17, 2022 the voters of Guilford County approved a \$1.7 billion bond referendum to pay capital costs of providing school facilities, including the acquisition and construction of new school facilities, the improvement and expansion of existing school facilities and the acquisition and installation of furnishings and equipment and the acquisition of interests in real property required therefor.

This item amends six of the individual school capital projects associated with the original approval and establishes twelve new School Capital Projects associated with the \$1.7 billion bond referendum. The board previously adopted \$300 million in school capital projects associated with the combined \$2 billion in voter-approved GO bond debt. This item adds \$256,340,032 million, bringing the total to \$556,340,032 million.
