THIS CONTRACT is hereby made, entered into, and effective as of July 1, 2017, by and between **GUILFORD COUNTY**, a body politic and corporate of the State of North Carolina, hereinafter referred to as the “**COUNTY**,” and **CHILDREN'S HOME SOCIETY OF NORTH CAROLINA, INC.**, hereinafter referred to as the “**CONTRACTOR**,” and also collectively referred to as the “**Parties**.”

W I T N E S S E T H:

WHEREAS, the Parties entered into a **CONTRACT** on a July 1, 2017, whereby the **CONTRACTOR** has agreed to provide room and board for children.

WHEREAS, the initial Contract may be revised or modified with a written Contract executed by both Parties; and,

WHEREAS, the Parties now wish to modify the terms of the Contract;

NOW, THEREFORE, the Parties mutually agree that the following changes are hereby made to the initial Contract as follows:

CHANGES The total amount paid by the County to the Contractor as referenced in Paragraphs 5, 6, 9, and Attachment B of the original contract has increased to an amount not expected to exceed \$1,620,000.00 (an increase of \$620,000.00). The Contractor will receive the Cost Model Rate if they

participate in an annual cost finding and rate setting process. If the Contractor fails to complete the rate setting process and/or is found ineligible to participate, the contractor will receive the Standard R&B Rates for the contracted fiscal year.

JURISDICTION. The Parties agree that this Contract is subject to the jurisdiction and laws of the State of North Carolina. The AGENCY will comply with bid restrictions, if any, and applicable laws, including N.C. Gen. Stat. §143-129(j) regarding E-Verify. Any controversies arising out of this Contract shall be governed by and construed in accordance with the laws of the State of North Carolina.

PRIOR AGREEMENTS. All other provisions of the initial Contract and subsequent modifications and revisions, are hereby ratified and shall continue in full force and effect without change, unless and until revised upon mutual written Agreement of the Parties, or terminated as provided herein.
