

**MINUTES OF BOARD OF COUNTY
COMMISSIONERS
OF GUILFORD COUNTY**

Greensboro, North Carolina
December 4, 2025

The Board of County Commissioners met in a duly noticed regular meeting on December 4, 2025 at 5:30 p.m., in the Commissioners' Meeting Room, 301 W. Market St., Greensboro, North Carolina.

2025-514 RESOLUTION HONORING THE LIFE AND LEGACY OF WILLENA CANNON

Adopt resolution honoring the life and legacy of Willena Cannon.

Pursuant to N.C.G.S. 158-7.1, hold a public hearing and consider approval of an economic development incentive grant to Paragon ID High Point US, Inc. in an amount not to exceed \$300,000 and a finding that the project will stimulate the local economy, promote business, and result in the creation of a substantial number of jobs in the County that pay at or above the County's median average wage; and upon approval, authorize staff to execute grant agreements, in accordance with terms and conditions of the proposal, consistent with the County's economic development incentive policy.

Legislation Text

Brantley Craft, High Point Economic Development, thanked the Board for their continued support of the Guilford County Economic Development Alliance. He noted that all economic development incentives are performance-based, and to be eligible, they must meet the terms of their contracts.

Vice Chairwoman Foster clarified that this was presented Monday night and was approved by the High Point City Council.

Kellen LaBonte, Senior Budget and Management Analyst, provided an update on expenses. He noted that revenues are performing as expected with sales tax actuals beginning to accrue after Q1, as these revenues are 3 months in arrears. He shared that the department continues to monitor federal and state revenues to determine impacts from the federal shutdown and any legislative changes.

LaBonte noted that expenses indicate that the vacancy rate is higher than in the previous year due to the staggered implementation of new positions. He provided updates of the Fire Districts, the opioid settlement fund, the general fund, department budgets, ARPA-enabled funds, and other annual funds for Board consideration.

County Manager Isler asked the Board to receive the budget performance report for reference only.

XIII. COMMENTS FROM COMMISSIONERS

Commissioner Gray-Hill spoke to the groundbreaking ceremonies at Sternberger and Allen Jay Prep. He shared that he hoped to see everyone this Saturday at the Greensboro Parade.

Commissioner Murphy noted the Grimsley Football game semi-finals tonight.

Commissioner Cooke echoed Commissioner Gray-Hill in congratulating Guilford County Schools on the groundbreakings. She noted NCACC training on school funding in a five-part series that will begin at 5:00 p.m. tomorrow.

Commissioner Cashion noted that on Tuesday, she attended the Carolina Theater's thank-you event for supporters.

Commissioner Tillman shared that it was an honor to speak at the Sternberger groundbreaking.

Commissioner Jones recognized the upcoming Rev. Cardes Brown's 50th Pastoral Anniversary Gala event. He noted the meeting with Commissioner Perdue regarding water quality testing around the Pleasant Garden Fire Department.

Vice Chairwoman Foster shared her attendance at the High Point Holiday Parade last weekend and her recent attendance at the Trillium Board meeting. She echoed the sentiments for the Guilford County Schools groundbreaking, noting the Allen Jay Elementary groundbreaking as the first school in High Point impacted by the 2020 bond.

Commissioner Perdue thanked Tommy Sluder and Jim Albright for their participation in the Pleasant Garden collaboration regarding water resources for the western North Carolina region.

Chairman Alston thanked the staff and the Commissioners for their representation of the Board for the Pleasant Garden water needs. He shared his support of the GCS groundbreakings. He recognized that Commissioner Jones was recently elected as the new President of the Greensboro Men's Club.

Vice Chairwoman Foster reiterated her appreciation for the Sigma Gamma Rho Sorority, Inc.'s Rhoer Club attendance. She shared the importance of exposing our youth to the political arena.
