- II. The Offeror, agrees to pay for the sum of \$4,232.56 for the afore-referenced real properties, payable to the County on the Date of Closing.
- III. The real property is being sold subject to tax liens and special assessments and taxes thereon. Therefore, all real property taxes, personal property taxes, assessments, tax liens, and special assessments against the real property will be the responsibility of the buyer.
- IV. **The above-referenced real property was acquired by the County through a Commissioner's Deed via foreclosure proceedings or other means. The County will not provide a warranty deed on this real property and the property is being sold as is, including, but not limited to any taxes, assessments, liens, easements, rights-of-way, and conveyances of record. - V. Other conditions affecting the purchase of the property will depend on any additional designations or conditions imposed by the Guilford County Board of Commissioners.

This offer shall be irrevocable for one hundred twenty (120) days from the date of execution; and unless failure by the County to accept this offer within one hundred twenty (120) days shall render this offer null and void. Upon acceptance of this offer within the prescribed one hundred twenty (120) day period, the County agrees to provide at least sixty (60) days from the date of this offer for the Offeror to tender the full

purchase price to the County in full settlement for the transfer of the real property. If the Offeror fails to make such settlement by the within the sixty (60) day period, the Offeror agrees that any payment deposited as earnest money shall be forfeited by the Offeror and shall automatically convert to an option fee which shall be retained by the County

IX. The Offeror acknowledges that the recording fee in the amount of twenty-six dollars and 00/100 (\$26.00) will not be covered by the County and that the undersigned will be required to present the recording fee via cash or check directly to The Guilford County Register of Deeds.

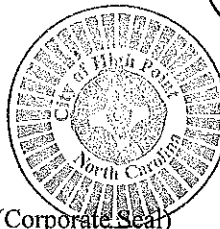
