The Board of County Commissioners met in a duly noticed regular meeting on August 4, 2022 at 5:30PM in the Commissioners' Meeting Room, 301 W. Market St., Greensboro; North Carolina.

VII. PUBLIC HEARINGS

A. 2022-345 PUBLIC HEARING ON ECONOMIC DEVELOPMENT INCENTIVE REQUEST

Pursuant to N.C.G.S. 158-7.1, conduct a public hearing and approve an economic development incentive in the amount of \$41,630 to IQE, Inc. to support the development of a new facility expected to generate approximately \$7 million in capital investment and thirty-one (31) new full-time jobs. Chairman Alston reviewed the public hearing requirements.

Marvin Price with the Greensboro Chamber of Commerce introduced the item. He noted IQE offered an advanced manufacturing center. The company is considering a strategic consolidation at Gallimore Dairy Road currently employing 50 employees. The expansion, if selected, would bring a \$7 million investment with 31 new jobs with the average wage of \$65,968 with additional benefits.

Chairman Alston and opened the floor for the public hearing.

There being no proponents, Chairman Alston opened the floor for opponents. There being none, Chairman Alston closed the public hearing.

Motion was made by J. Carlvena Foster and seconded by Kay Cashion to pursuant to N.C.G.S. 158-7.1, conduct a public hearing and approve an economic development incentive in the amount of \$41,630 to IQE, Inc. to support the development of a new facility expected to generate approximately \$7 million in capital investment and thirty-one (31) new full-time jobs. Clyde Harding, Environmental Services Program Manager, reviewed the ordinance authorizing solid waste licensing.

Leslie Bell, Planning and Development Director, introduced the item.

Chairman Alston and opened the floor for the public hearing.

1. Ms. Norma Yanez, government contracts manager for GFL, spoke in support of the increase for her organization.

2. Tracy Nestor with Republic Services spoke to their need for an increase in their base rate. Ms. Nestor reviewed their request and communications with county team members. She asked that the Board respectfully consider their increase request.

3. Shane Walker, Area President of Republic Waste, shared that we are grateful to serve the residents of Guilford County and provide over 85% of the collection. He noted that their last increase was in 2019 and since that time we have spent over \$4 million in investment in trucks and \$8 million in recyclable staffing and management. He noted that their service rates remained at 99.7% during the pandemic. He noted that inflation has been very impactful for their agency. Walker recognized that they have only had two increases since 2008 and has created this pressure point. He thanked the Board for their time.

Chairman Alston opened the floor for opponents. There being none, Chairman Alston closed the public hearing.

Motion was made by Mary Beth Murphy and seconded by J. Carlvena Foster to set the maximum fee for waste haulers at \$25.50 with no CPI increase, current backdoor service fees to remain at an additional \$3 for backdoor service for GFL and Republic Services, and \$7 for Randolph County Garbage Service to remain in place.

Chairman Alston thanked the waste haulers for their patience in working with them and allowing the Board members to review the information.

Commissioner Murphy thanked them for their service and willingness to support the residents. She shared that they try to strike a balance to meet the business needs with the burden on the residents. She noted while this is not exactly what they are asking for, it is an 18% increase.

Planning and Development Director Leslie Bell introduced the case. He reviewed the legislative hearing held by the Planning Board. Bell reviewed photos of the property in question.

Bell noted the requirements of the Board to make a consistency statement.

Commissioner Conrad questioned staff's recommendation.

Bell stated its staff's recommendation that this be approved.

Chairman Alston question what the Planning Board's recommendation was

Bell stated the Planning Board's recommendation was to deny the request.

Chairman Alston opened the floor for the public hearing.

1. Amanda Hodiern, representing the Shaw Family and the contractors, noted that the client is T. Cooper James, a local developer here in Greensboro, who primarily conduct retail development. He noted that they are a part of the community and will remain property holders. She noted that they did conduct a traffic study early in this process in order to answer the Board's questions. Hodiern stated John Davenport with Davenport Engineering who conducted the traffic study is here.

Bob Dissenger with Evans Engineering was introduced as handling the civil and design work.

Hodiern noted that the comprehensive plan does call for commercial in this location and the question to the Board is not if it should be commercial, but what type of commercial zoning should be allowed. She noted that they were able to hold a community meeting on July 20th and noted that the site is over 30 acres.

Hodiern noted that the property was labeled as inconsistent with the comprehensive area plan. This is a commercial contemplative parcel. She noted that they need to be a moderate commercial note. We need the language plan adjustment to moderate commercial.

Hodiern noted that the Norther Lakes area has seen more growth than any area in the county. She spoke to the request to customize the request with restrictions listed in the application limiting use, and items that were removed from their applications, such as multi-family, shelters, shooting ranges, kennels and pet grooming, hotels and motels, auto repair, gas stations, vehicle or tire sales, bars, and taverns among others. Hodiern noted this would be a phased approach.

2. Robert Shaw, current property owner, shared that his father served on the Planning Board for about 14 years. He shared that they believe the land is best suited for general business and that the land cannot hold a lot of residential houses and commercial business will serve the community well.

3. Milton Shaw shared his support of the sale.

Chairman Alston announced the end of the allotted time and closed the floor for proponents.

Chairman Alston opened the floor for the opponents.

1. Nicole Martin, community member speaking on behalf of the community. She noted that the community is not averse to change from agricultural to residential or even light commercial. She noted that the residents are actively against the rezoning to general commercial. Martin noted

that over 700 residents have spoken against the rezone. She noted that as representatives of the community, it is the role of the elected to carry out the will of the people.

Martin noted that within a 7-mile radius of the land in question, you can find zoned commercial mixed use. She noted that we have three Dollar Generals in less than 3 miles. She noted that of all of the areas, there is also vacant spaces needing to be filled and it is simply a matter of supply and demand.

Martin spoke to security, increased traffic, light and noise pollution. She urged the Board to choose to say no. She asked the Board to remain consistent with the Planning Board decision. Martin spoke to other properties vacant that are more feasible for commercial rezoning that are not adjacent to the school. She urged the Board to deny the rezoning.

Martin asked for additional mandatory conditions: all easements should be taken from the applicant's land; the removal of alcohol and tobacco tenants; mandate all tenants have business operations that open at 9:00AM and close by 11:00PM; tall fences; older, more developed trees for a barrier for people from getting onto the school grounds and reduce light development.

2. Guilford County resident and business owner spoke against the rezoning. He noted that we haven't spoken about the infrastructure for the trailers to deliver to the location, or the number of cars going to the schools every day. He noted that the current traffic now is overburdened. The septic field currently smells at the high school and adding another large one is not fair to our kids.

3. Guilford County resident spoke against the rezoning and shared that he recently built a home in 2019 under the current comprehensive plan. He asked if the Board decides to move forward with this plan, that the property must retain all water from the structure on the property.

4. Guilford County resident located off of Church spoke in denial of the request. She noted that school will be back in session in one month with young and impatient drivers. She noted that Guilford County Schools have conducted a traffic study on their property with a significant backlog on Spencer Dixon Road. She asked the Board for the long-range plan for Guilford County Schools and the capacity of the High School and Middle School. She noted that with all of the new residential housing, would Guilford County want potential land for future expansion of the schools. She asked the Board to support what the Planning Board has decided.

5. Phillip Shoester, local resident, spoke to safety concerns. He shared that there is no other school in the county that is located directly next to a commercial development. He noted the continued growth of the schools, current traffic concerns, and anticipates additional growth needs of the school.

6. Deb, a Guilford County resident, shared that they see many accidents in that area. She noted that she and her husband drive busses for Northern Guilford middle and high school. It is currently impossible to get the children to school on time due to the traffic backups every day. It takes 10-15 minutes to make a left out of the parking lots. She shared that they chose to move out into the community because they do not want our community to look like Battleground Avenue.

7. Guilford County resident spoke to the resistance for this request. Highway 150 is currently used as a cut through for truck drivers. She noted that as residents, they chose to move away from commercial development. She asked the Board to deny the request.

8. Olivia Tolbert, recent graduate of Northern High School, shared that it is very stressful to turn into and come out of the parking lot of the schools, and shared her worry of a commercial property being built next to the school.

9. James Morris, local resident, noted that morning rush hour traffic can back up to over a quarter of a mile with left turners currently running the light as they have no other choice to get out of there. He shared that this proposal is unimaginable. He shared the community's desire to not have commercial property and would be destroying the quality of life. He shared water is an issue and wells are starting to run dry. These issues should be addressed first before adding more commercial properties.

10. Local resident shared that he is a volunteer at the schools and due to traffic, the middle school and high school now operate at different times due to the traffic.

Chairman Alston announced the end of the allotted time and closed the floor for opponents. He opened the floor for proponents three (3) minute rebuttal period.

4. John Davenport, employee of the firm who conducted the traffic study, shared that there will be improvements that will have to be made to handle the traffic.

5. Bob Dischinger, owner of Evans Engineering, noted the concern of runoff and there is about two acres that does drain on the north side of Highway 150 and that they will look into the matter.

Chairman Alston announced the end of the proponent's rebuttal period and opened the floor for the opponents three (3) minute rebuttal period.

11. Nicole Martin noted the community is not against change, it is the concern that this property will be general commercial next to a school. She recognized the need for developers to make money and noted the loss of the Shaw family. Martin noted that this study was conducted in May when 62% of the community is still working from home and the schools were not in session. She noted the span of the drop-off and pick-up school cycle.

12. Resident spoke to the opportunity for Guilford County to preserve this land and give alternate uses to the land owners.

Motion was made by Justin Conrad and seconded by Kay Cashion to approve inconsistent plan amendment from Agricultural (AG) and Residential Single Family (RS-40) to ~~Conditional Zoning—General Business (CZ-GB)~~ Moderate Commercial.

1. This approval also amends the Northern Lakes area plan.

2. The zoning map amendment and associated Northern Lake area plan amendment are based on the following changes and conditions in the Northern Lakes area plan:

The parcel is located at the key intersection of North Carolina Highway 150 and Spencer Dixon Road. A GB zoning would create opportunities to provide retail and services in the area. Limited Office conditional zoning is adjacent west and Limited Business conditional zoning is to the north across North Carolina Highway 150 west. North Carolina Highway 150 is a major growth corridor in Guilford County.

3. Amendment is reasonable and in the public interest because:

Although inconsistent with the recommendations of the Northern Lakes area plan, the requested action is reasonable and in the public interest because it is in an area with several residential subdivisions and a public school. The parcel is located at the key intersection at North Carolina Highway 150 and Spencer Dixon Road. A GB zoning would create opportunities to provide retail and services in the area. Limited Office conditional zoning is to the adjacent west and Limited Business conditional zoning is to the north across North Carolina Highway 150 west.

Bell asked the Board if they will amend the motion to moderate commercial.

By General Consensus, the Board amended the motion.

Commissioner Murphy questioned the DOT process in how they are involved to make improvements in this area.

Bell stated that the Department of Transportation is a partner and would need a review of the site plan. The technical review committee would submit recommendations to the DOT.

Commissioner Murphy asked of the developer is obligated to meet the DOT recommended improvements.

Bell stated yes.

Commissioner Murphy shared remarks on behalf of Commissioner Cooke. She shared that while she is absent due to the passing of her mother, she has been deeply invested in this project noting the primary concerns are traffic and safety. She shared that Commissioner Cooke reached out to the NC DOT and Guilford County Schools.

The NC DOT shared that the staff completed a traffic study over the last 5 years with a total of 8 reported accidents at the intersection. The DOT determined that an advanced warning system should be added but that the intersection is safe and working properly.

The DOT completed a congestion study at the request of the schools. She noted personal accounts being circulated of frequent accidents but noted no formal reports to substantiate those. She spoke to GCS and shared that there are no plans to expand Northern High School or Northern Middle school and takes no position on sidewalks and there are no discussions on expansions for the site.

Commissioner Conrad questioned Mr. Davenport on the traffic study and how many cars per day come through that intersection or on Hwy 150.

Davenport stated that they do not look at peak hours or daily volumes. 5,900 vehicles a day on Hwy 150 per day.

Commissioner Conrad asked how many trips the intersection can maintain with improvements and as it currently exists.

Davenport shared that they will review our data and either concur or ask for more information. He shared that they will look at how the intersection is working today and can make recommendations on the turning lanes to help improve flow.

Commissioner Conrad shared that he has had the opportunity to work with him in the past and is familiar with the thoroughness and quality of his work.

Commissioner Conrad in listening to both presentations, both parties recognize that there will be growth in the community. He shares his preference on development to use local developers who has a vested in interest in making Guilford County better.

Commissioner Cashion thanked everyone who spoke this evening she spoke to the changing scenery as she travels across the county. She noted that the Planning Board denied the request by a 3-2 vote. She would like Bell to speak on staff's position and noted that the developers have offered up several conditions and will those be in perpetuity?

Bell noted that if you do conditional zoning, those conditions will ride with the property and will remain. In regard to staff's position, this is a major corridor along Hwy 150. We try to put commercial development at nodes near major intersections and is consistent with the general patterns of the land use plan for concentrated commercial nodes.

Commissioner Murphy spoke to her experience as a teacher regarding school safety near commercial districts. She noted that her most recent school field trip where they walked to Guilford College and stopped at the Chick-fil-A. This is a great resource near the school, so they have access to the amenities close to their community. She spoke to the traffic congestion concerns brought forward, which is consistent with what she experiences during times of drop-off and pick-up, and the uniqueness of this circumstance to possibly get road improvements at this intersection to help with these concerns.

Commissioner Jones questioned some of the changes to the UDO from a lighting perspective.

Bell noted that a lighting plan will need to be submitted and the plan now requires new fixtures to direct the light downward to help eliminate light pollution to keep the light pointed downward. He noted the use of the adjacent property dictates the lighting requirements.

Commissioner Jones questioned an “hours of operations” condition in a legislative hearing.

Bell noted that typically there is not those types of conditions, as we normally see zoning for potential impacts associated with that particular development, conditions should address the concerns with that development.

Commissioner Jones asked Bell to clarify traffic plans from a site plan perspective.

Bell stated at TRC, you have a number of county departments and divisions and the NC DOT. That review is done concurrently so if there any impacts or changes needed to be made, they are made in concert and that gives you more of a holistic view of what the development will ultimately look like.

Commissioner Jones stated if this request is approved tonight, there is a significant amount of work and input that will be done afterwards though TRC. The local nature of this particular developer will offer opportunity for continued dialogue with the community.

The Board recessed the meeting at 7:38PM.

Vice Chairwoman Foster asked what will happen to this position at the end of the grant program.

Isler noted that there is a need to continue to provide these services and as we get near the end of the 18-year mark, we will evaluate that necessity.

Vice Chairwoman Foster questioned who that position will report to.

Isler noted that for now it will be me, but traditionally, it falls under Public Health so as we build out this program, we will evaluate its permanent location.

Chairman Alston noted that the health department should be a part of this.
