The goal of the Section 5310 program is to improve mobility for seniors and individuals with disabilities throughout the country, by removing barriers to transportation services and expanding the transportation mobility options available. Toward this goal, FTA provides financial assistance for transportation services planned, designed, and carried out to meet the special transportation needs of seniors and individuals with disabilities in all areas. A senior is an individual who is 65 years of age or older and the term 'disability' is defined in section 3(1) of the Americans with Disabilities Act of 1990 (42 U.S.C. 12102). All 5310 projects (Operating, Capital Purchase of Service, and Mobility Manager) are competitive and will be scored based on a set of criteria aligning with IMD's mission and goals. Funding for any given project is not guaranteed.

Answer: Work with Human Services Agencies whose population they serve are the elderly and disabled. Organizations such as Senior Resources, Adult enrichment Center, Disabled Veterans have waiting list for clients they could serve but due to transportation issue cannot.

Answer: Transportation is an especially important service for older adults and with disabilities. There are three services that are widely considered the most important in allowing older adults to remain in their homes rather than face with long-term care facility placement: home delivered meals, in home care and Transportation. Older adults rely on this transportation to get them to their doctor's appointments. Too many times, older adults have been discharged from hospitals with a two-week follow-up appointment with their doctor, but they never showed up because they did not have a ride to get them there. Many of these seniors have ended up right back in the ER because they did not have or weren't aware of available transportation. Transportation allows older adults to get to the grocery store, the pharmacy or social services agencies. It also allows seniors to get to other places like senior meal program sites where they receive nutritious meals and adult day care, where seniors can be cared for while their caregiver goes to work or takes care of other important businesses.

Answer: Guilford County will promote public awareness by having meeting with agencies and groups and by marketing with flyers and advertisements. Number of trips, clients and the service area that we serve. Running reports from Trapeze data as well as having oversite of current vendor productivity and efficiency.

Answer: Irma is the Transit Manager for Guilford County Transportation and Mobility Services servicing Guilford County. She has been working in public transportation for over 31 years. She began her career in 1995 with the Greensboro Transit Authority as a Paratransit Operator transporting passengers with special needs, older adults and the public focusing on safety and timeliness. She quickly developed a passion for helping others and wanted to learn more about other transit agency functions. She received training in finance, trip reservations, trip scheduling and dispatching.

16. Describe how the applicant will manage risk and provide for the safe delivery of services.

Answer: By providing continuous training to our operators on safety procedures for the operation of vehicle and client care.

17. Describe how the transit system intends to seek reimbursement for the services.
