The County approves, solely for the purposes of meeting the requirements of the Internal Revenue Code of 1986, as amended, the issuance of not to exceed \$25,000,000 in tax-exempt education revenue bonds by the Public Finance Authority for the benefit of Piedmont Classical High School.
