	<u>Background:</u>	Guilford County has received a 2nd funding allocation of \$831,312 for the Low-Income Household Water Assistance Program (LIHWAP) from the NC Department of Health & Human Services (NC DHHS) to be used to continue the program in FY 2022-23. This program provides emergency assistance to low-income households, particularly those with the lowest of incomes that pay a high proportion of their household income for drinking and wastewater services. Eligibility for the program will be income based for household at or below 150% Federal Poverty level. Households receiving benefits through Low-Income Energy Assistance Programs (LIEAP), Food & Nutrition Services (FNS) or Supplemental Nutrition Assistance Programs (SNAP) will automatically be eligible. Funds must be paid to owners or operators of public water systems or treatment works to reduce arrearage of and rates charged to eligible households.
		After the first allocation was received by the County in Fall 2021, the State developed a statewide portal for water providers to complete their vendor agreements so individual county-level agreements do not need to be completed or updated for this allocation period.

2.	<u>2022-427</u> Background:	APPROVE HOME AND COMMUNITY CARE BLOCK GRANT (HCCBG) AGREEMENT AND COUNTY FUNDING PLAN FOR FY 2022-23 The FY 2022-23 adopted budget included Home and Community Care Block Grant (HCCBG) funding for aging adult in-home aide, transportation and other services for seniors such as adult day care, group enrichment, community nutrition and home delivered meals, senior center operations and housing assistance. It is estimated that more than 8,270 seniors will benefit from these block grant-funded services.
		The service providers under this agreement are the Adult Center for Enrichment, Inc. d/b/a Well-Spring Solutions, PTRC Community Development, Guilford County DHHS-Social Services Division, Guilford County Transportation and Senior Resources of Guilford.
		Total block grant funding for FY 2022-23 is \$3,103,620 (an increase of \$598,936 from the estimate in the FY 2022-23 adopted budget) plus \$123,949 (a decrease of \$10,031) in Department of Agriculture NSIP funding. The required local match is \$344,846 which will be met through in-kind services and existing county funding. This match includes the use of county funds to cover the required local match for Well-Spring Solutions, Senior Resources of Guilford and PTRC Community Development.

The purpose of the transfer is to provide funding for twenty (20) county employees to participate in the National Association of Counties (NACO) High Performance Leadership Academy. Transfers were approved by the County Manager, or designee thereof, under authority granted in the FY2023 Budget Ordinance, Section 10. The Room Occupancy & Tourism Development Fund was amended by \$892,627 to reflect actual revenues received in FY2022 to remit to the Guilford County Tourism Development Authority and City of High Point due to continued strong economic growth and recovery. This amendment was approved by the County Manager, or designee thereof, under authority granted in the FY2022 Budget Ordinance, Section 4. 	Background:	This change order applies to the CM at Risk Contract between the
		County and Samet for the construction of the new Sheriff's Office.
		To secure an order for structural steel Samet requested that the County expedite the bid process ahead of the Phase 2 construction package. The structural engineer provided the steel design package and Samet put out a request for bids.
		Three (3) firms responded with bids. Bids ranged from \$1,599,000 to \$1,740,000. After reviewing the bids, Samet confirmed that SteelFab was the lowest responsive, responsible bidder with a price of \$1,599,000. This change order includes markups and contingencies in accordance with the terms of the original CM at Risk contract to bring the total cost of the change order to
		\$1,758,813. Samet provided information that this change order will have 18.5% MWBE participation. This will increase the overall project participation rate from 31% to 33%.

2.	<u>2022-412</u>	TA TRUCK STOPPROPOSED AMENDMENT TO INTERLOCAL AGREEMENT (CONTRACT NO. 20879-07/05-035) BETWEEN GUILFORD COUNTY (ON BEHALF OF THE GCSO) AND CITY OF BURLINGTON (ON BEHALF OF THE BURLINGTON PD)
	<u>Background:</u>	On July 1, 2005, the City of Burlington annexed a portion of Guilford County wherein TA Operating Corporation (d/b/a as "Travel Centers of America") owns and operates a business known as the "TA Truck Stop" at 1101 NC Highway 61, Whitsett, NC (Exit 138 of U.S. Interstates 85 and 40). In July 2005, an initial Interlocal Agreement was entered into between Burlington and Guilford County wherein the Guilford County Sheriff's Office (GCSO) would continue to provide certain law enforcement services at the TA Truck Stop for a specific fee to be charged on a "per call for service" basis. That interlocal agreement has remained unchanged for seventeen (17) years. The Parties seek to amend that original interlocal agreement to increase the price "per call for service" charged to Burlington from \$115.00 to \$230.00 per call and to limit and delineate the scope of law enforcement services provided by the GCSO at the TA Truck Stop. Approval will result in a small annual revenue increase of approximately \$8,000 for Guilford County.

3. <u>2022-429</u> PC EQUIPMENT REPAIR & MAINTENANCE SERVICES

Background: Guilford County has been using Computer Service Partners, Inc. for PC equipment repair and maintenance services. To ensure that the County is receiving the most cost-effective service, a Request for Proposal (Bid #20067) was issued by Guilford County Purchasing on April 12, 2022, with bids due on May 5, 2022. Bids from two (2) companies were received by the deadline. The bid responses were evaluated by a committee using the selection criteria stated in the bid document. Computer Service Partners received the highest score and is recommended to be awarded the contract for PC Equipment Repair & Maintenance Services with a bid of \$114,996 per year for three (3) years for a total of \$344,998, with two (2) optional one (1) year extensions at the same pricing and terms and conditions upon mutual written agreement of both Parties. The Guilford County MWBE Director has completed a Good Faith Effort review as indicated on the attached memo. **Requested Action:** Approve awarding Computer Service Partners the contract, in substantial form, for PC Equipment Repair & Maintenance Services with a bid of \$114,996 per year for three (3) years for a total of \$344,998, with two (2) optional one (1) year extensions. 	<u>Background:</u>	Voluntary Agricultural Districts (VAD) and Enhanced Voluntary Agricultural Districts (EVAD) were developed by the NC Department of Agriculture to encourage the preservation and protection of farmland from non-farm development.
		During its July 18, 2022 meeting the Guilford County Agricultural Advisory Board approved the following application:
		 VAD Application #2022-02, being 83.51 acres and comprised of two (2) Tax Parcels (#101069 @ 24.49 acres, #101042 @ 59.02 acres) all owned by Craven Smith and Claude Smith of Gibsonville, NC. To date, approval of this application brings the total number of VAD and EVAD parcels to 428, totaling 18,989.02 acres enrolled. Of these totals, 385 parcels comprising 17,223.34 acres are enrolled in VAD, and 43 parcels comprising 1765.68 acres are enrolled in the EVAD. C. <u>2022-448</u> APPROVE NC DEPT. OF COMMERCE RURAL BUILDING REUSE GRANT APPLICATION FOR BETHANY MEDICAL CENTER, PA

Background: Bethany Medical Center, PA, has requested that Guilford County a NC Dept. of Commerce Building Reuse apply for and Infrastructure grant in the amount of \$592,858 and is seeking to renovate a 4912 sq. ft. vacant building located at 108 W. Main Street, Jamestown, NC 27282 (owned by the Peters Development, LLC). The company is an independent group of health care providers with a mission to provide excellent care through a multi-specialty approach from prevention to intervention of potentially life-threatening health problems. The company has 18 locations in the Piedmont Triad area with the majority of those locations in Guilford County.

> The company has been in business in NC for 35 years and currently employs 473 full-time employees and 47 part-time employees. Bethany Medical Center, PA is projected to create thirty (30) new jobs with an average annual wage of \$54,453 with 89.5% of employer-paid health insurance. The average Guilford County private sector wage (2022) is \$53,994 as published by the NC Dept. of Commerce.

> Eligible applicants are units of local government located in either a Tier 1 or Tier 2 county, or a rural census tract in a Tier 3 county. Guilford County is a Tier 2 county.

The five percent (5%) local match can be included in the 50% from local resources. Local resources procured by the local government may come from the business, property owner, or others but may not come from other state or federal grant funds.

This grant, if approved by the State, would be in the form of pass-through funding in the form of a loan to the property owner, meeting the investment forgivable upon and iob creation requirements. The funds would reimburse the property owner for eligible project expenses contingent upon performance review and verification by the State (see attached application). Funds paid are subject to repayment to the State to the extent that the investment and job creation requirements are not met. To avoid that contingency, a Supplemental Agreement will be used which provides that the grant funds will not flow from the State to the County and from the County to the property owner until all the investment and job creation

requirements have been met and contains commitments by the property owner (Peters Development, LLC) and the business (Bethany Medical Center, P.A.) that they will satisfy the 5% local match. A draft Supplemental Agreement is attached for approval in substantial form. This request also includes adoption, in substantial form, of the associated resolution in support of this building reuse grant application.

No County budget action is necessary at this time as the request of the Board of Commissioners is to approve submittal of the NC Dept. of Commerce Rural Building Reuse Grant Application for the project. If awarded, grant acceptance and the corresponding budget amendment would be subject to approval by the Board of Commissioners on terms it deems appropriate.
