# MINUTES OF BOARD OF COUNTY COMMISSIONERS OF GUILFORD COUNTY WORK SESSION

Greensboro, North Carolina December 9, 2021

The Board of County Commissioners met in a duly noticed Work Session at 6:00PM using the web-based virtual platform, Zoom.

## I. WELCOME AND CALL TO ORDER

Chairman Melvin "Skip" Alston welcomed those present and called the meeting to order at 6:02PM.

#### II. NEW BUSINESS

# A. APPROVE PURCHASE AND UPFIT OF LAW ENFORCEMENT VEHICLES

Chairman Alston introduced the agenda item.

Commissioner James Upchurch asked Captain Aldous Heron with the Sheriff's Department to speak to the item in detail.

Captain Heron spoke to the Board. He discussed the bidding process for this item and the vehicles involved. Four vendors submitted written bid proposals for a total of 29 law

enforcement vehicles. Captain Heron noted the difficulties with available inventory and discussed the safety qualifications and typical lifespans for patrol vehicles.

Commissioner Upchurch clarified that the request tonight is due to current patrol vehicles in our inventory that have met their lifespan limit and to replace damaged vehicles.

Chairman Alston noted these vehicles were included in our budget.

Motion was made by Vice Chairman J. Carlvena Foster and seconded by Commissioner Carly Cooke to approve the purchase of 29 Law Enforcement vehicles from the four vendors listed in the agenda background at a total dealership base price of \$939,233 (rounded). The additional costs associated with the vehicle purchases and upfit expenses, including for the five vehicles assigned to support the Behavioral Health Center, will come from funds available in the Law Enforcement FY 2022 budget.
