THIS CONTRACT AMENDMENT is hereby made, entered into, and effective as of July 13, 2022, by and between GUILFORD COUNTY, a body politic and corporate of the State of North Carolina, hereinafter referred to as the "COUNTY," and Samet Corporation, hereinafter referred to as the "CONTRACTOR," and also collectively referred to as the "Parties."

WITNESSETH:

WHEREAS, the Parties entered into a CONTRACT on January 1, 2021 and amended on April 5, 2022, whereby the CONTRACTOR agreed to provide the following goods and/or service(s) to the COUNTY: CMAR for Sheriff's Office Building located at 401 W. Sycamore St. Greensboro NC, and

WHEREAS, the initial Contract may be revised or modified with a written Contract executed by both Parties; and,

WHEREAS, the Parties now wish to modify the terms of the Contract; and,

NOW, THEREFORE, the Parties mutually agree that, as of the effective date of this Contract, the following changes are hereby made to the initial Contract as follows:

CHANGES:

This Amendment is needed to add the Advance Structural Steel Award to the existing contract as referenced by Attachment A. The financial exposure to the County will not exceed \$7,729,975.00 from \$5,971,162.00, an increase of \$1,758,813.00. Payment will be made only from budgeted funds in accordance with N.C.G.S. Chapter 159.

JURISDICTION. The Parties agree that this Contract is subject to the jurisdiction and laws of the State of North Carolina. The CONTRACTOR will comply with bid restrictions, if any, and applicable laws, including N.C.G.S. Chapter 143-129(j) regarding E-Verify. Any controversies arising out of this Contract shall be governed by and construed in accordance with the laws of the State of North Carolina.

PRIOR AGREEMENTS. All other provisions of the initial Contract and subsequent modifications and revisions, are hereby ratified and shall continue in full force and effect without change, unless and until revised upon mutual written Agreement of the Parties, or terminated as provided herein.

ASSUMPTIONS, CLARIFICATIONS, & EXCLUSIONS

I. ASSUMPTIONS & CLARIFICATIONS

- This GMP Change Order is based upon the Phase 2A Bid Package #5B drawings and specifications.
- Scope of work will be completed in accordance with sealed drawings, specifications, and clarifications as identified below and in the current Document List. See attachment A-5 current Document List for details. In the event of a conflict, assumptions and clarifications noted herein shall supersede.
- Notwithstanding any other provisions of the Contract Documents, the Contract Sum is based on the current market prices and availability of the building materials and components required for the Work (for example only, and without limitation, concrete, steel, plywood, lumber, drywall, plumbing and electrical products containing copper, appliances, etc.) (collectively, "Building Materials"). The Owner and Construction Manager recognize that the market for these Building Materials can be volatile, and sudden increases in the price of the Building Materials and Building Materials shortages can occur based on national and international events that affect the market for such Building Materials. Accordingly, if following the date of this Guaranteed Maximum Price Amendment, an increase in the cost of Building Materials occurs, through no fault of the Construction Manager, then the Construction Manager shall be entitled to a change order increasing the Contract Sum in the amount of the actual additional cost incurred by Construction Manager to obtain the Building Materials. Conversely, if following the date of this Guaranteed Maximum Price Amendment, a market shift results in a decrease of more than 2.5% in the cost of Building Materials, the Owner shall be entitled to a deductive Change Order decreasing the Contract Sum in the amount of the decrease in excess of 2.5% in the cost of Building Materials; provided, however, that Subcontractors and suppliers who have contracted for the procurement of materials to guarantee pricing shall not be subject to a deductive Change Order in the event such Building Material costs later decrease. If the escalation is between a 0 to 2.5% increase the construction contingency will cover the increase costs. If the escalation is over a 2.5% increase the funds paid to Samet Corporation will come from a Change Order from Guilford County.
- Substantial Completion: The Substantial Completion date for the overall Project will be developed, agreed to and incorporated into this Agreement as part of Bid Package #2. The initial Substantial Completion dates for Phase 2A, Bid Package #5B Advance Structural Steel of Bid Package #2 are as follows:
 - Structural Steel Fabrication & Delivery April 28, 2023
 - Structural Steel Erection September 30, 2023
- General Allowance Costs in Attachment A-6 are based on estimated amounts. Estimated costs
 are based on work as shown in Construction Documents and outlined herein. The Construction
 Allowances cost for this GMP Change Order will be reconciled via Owner change order after
 receipt and evaluation of Trade Package Subcontractor pricing by the Construction Manager.

ALLOWANCES

All Allowances included herein are in addition to all Allowances and Unit Prices included in earlier contract modifications. Additional Allowances and Unit Prices will be added in the Final GMP.

I. GENERAL ALLOWANCE ITEMS

- A. The following General Allowances are outlined below for this Trade Package Scope of Work and included within this GMP Change Order.
- B. Each applicable Trade Subcontractor shall include the established general allowances within its Lump Sum Base Bid Proposal. Specific general allowance descriptions are outlined below for each respective Trade Package Scope of Work. All general allowances shall include all profit, overhead, supervision, survey/field engineering services, materials, labor, equipment, taxes, insurance, and any other miscellaneous incidental items required to complete the general allowance work activity. Any work, if required to use a certain general allowance, shall only proceed upon written authorization by the Construction Manager. All general allowances shall be broken out as separate line items within each Trade Subcontractor's Schedule of Values. At the option of the Construction Manager, the Construction Manager may elect to deduct the allowance values of each allowance from the subcontractor's contract amount at any time.
- C. General Allowances shall be included in the Subcontractor's Base Bid in addition to the requirements defined within the Trade Subcontractor's Scope of Work.

CONTINGENCY

I. CONSTRUCTION CONTINGENCY

In accordance with the Contract Agreement between the County of Guilford (the Owner) and Samet Corporation (the Construction Manager) for Phase 1 of the Project, "Future Construction Manager's Contingency" for Phase 2 and 3 (to be determined at that time) would be based on the awarded cost of the work at 3%. Further, these future contingency amount(s) will be allocated to the project scope via future Change Orders to include future Bid Package Phases.

Accordingly, we have included within our Attachment A-1 Itemized Statement, the amount defined below for exclusive use to manage this portion of the project. Reference Attachment A.1 - Exhibit A Itemized Statement for Phase 2A - Advance Bid Package 5B Structural Steel for specific calculation of Contingency Amounts.

The Construction Manager's Construction Contingency shall be used to expedite the work, additional project staffing if needed to facilitate schedule, correct deficient work, address scheduling and coordination problems, correct scope gaps in the bidding of the project, correct code and regulatory deficiencies and/or to address other unforeseen conditions that are not submitted and approved as the subject of a Change Order in accordance with the terms of this Agreement. The Construction Manager's use of the Construction Contingency fund shall be adequately documented by the Construction Manager. Items subject to being covered by the Construction Contingency shall not be the basis for a Change Order request increasing the Guaranteed Maximum Price.

This Contingency is based on the awarded Cost of Work at 3 percent.
