Enclosed for appropriate signatures are two copies of the Home and Community Care Block Grant Agreement (DAAS-735) for State Fiscal Year (SFY) 2023. Please sign and return **one** copy to the attention of Yolanda Davenport in the envelope provided.

Again, this year, the PTRC Area Agency on Aging is sending the Agreement (DAAS-735) separate from the County Funding Plan (DAAS-731) in order to ensure uninterrupted Home and Community Care Block Grant services to older adults in our communities.

Since the Agreement (DAAS-735) is entered into pending preparation of the County Funding Plan (DAAS-731) by the PTRC Area Agency on Aging, the timeliness of signing and returning the Agreement (DAAS-735) is necessary in order for us to release checks at the end of August to the local county funded HCCBG Partners.

Please note for Adult Day Care/Health Services that effective July 1, 2022, Session Law 2021-180 - Section 9A.3B.(a) G.S. 143B-181.1 (page 179) directed the Social Services Commission to amend rule 10A NCAC 06T.0201 for adult day care, adult day health and associated transportation as it relates to maximum reimbursement rates and thus the capped rates for these services have been removed. Therefore, the DAAS 731 County Funding Plan will now reflect full non-capped Adult Day Care and Adult Day Health rates. Approval of the DAAS 731 County Funding Plan authorizes acceptance of the full non-capped Adult Day Care and Adult Day Health rates.

As we continue to change and respond to the growing numbers and needs of local seniors, the PTRC Area Agency on Aging will maintain the best possible services and available opportunities to our public officials, local funded partners, and most of all, our communities' older adults. Our entire team looks forward to working with you in the year ahead. We are available to visit you,
