## I. WELCOME AND CALL TO ORDER

Chairman Henning called the duly noticed meeting to order at 10:11 AM for the purpose of discussing ongoing Guilford County Animal shelter operations, as a result of being informed by the State Agricultural Commission that as of 8:00am on August 17, 2015, the contractor's license to operate had been revoked and a criminal investigation regarding allegations of animal cruelty, misappropriation of County funds, and misuse of controlled substances was under way.

## II. NEW BUSINESS

- A. Direct the County Manager to terminate the contract with United Animal Coalition for the operations of the Animal Shelter and authorize the County Manager to assume operations and take all other necessary steps to operate the facility.
- B. Authorize the County Manager to establish a Fee Schedule associated with Animal Shelter services, consistent with the current schedule.
- C. Authorize County Manager to enter into all necessary Contracts and Services Agreements for the Animal Shelter to ensure immediate and ongoing operations.
- D. Amend the Budget Ordinance, Section A, to authorize the County Manager to accept and appropriate gifts, in-kind services, and monetary donations up to \$25,000.00 per donation.

A four-part motion was made by Vice Chairman Jeff Phillips, seconded by Commissioner Kay Cashion, to:

- A. Direct the County Manager to terminate the contract with United Animal Coalition for the operations of the Animal Shelter and authorize the County Manager to assume operations and take all other necessary steps to operate the facility;
- B. Authorize the County Manager to establish a Fee Schedule associated with Animal Shelter services, consistent with the current schedule;
- C. Authorize County Manager to enter into all necessary Contracts and Services Agreements for the Animal Shelter to ensure immediate and ongoing operations; and
- D. Amend the Budget Ordinance, Section A, to authorize the County Manager to accept and appropriate gifts, in-kind services, and monetary donations up to \$25,000.00 per donation.
