



Guilford County Purchasing Event 518 for Guilford County Emergency Services — EMS Division Stryker Stretcher equipment & supplies

General Specifications

Guilford County is soliciting bids to establish a Price Only Contract for: Stryker Stretcher equipment & supplies. The purpose of this bid package is, therefore, to obtain competitive bids in accordance with the North Carolina Purchasing Laws and the Guilford County Purchasing Policies.

The Price Only Contract shall initially be for three years with the option to renew for one additional, one-year renewal period. This is a Price Only Contract, which means there are no guarantees as to the minimum or maximum amount ordered and dollar amount expended.

<u>Cancellation Clause:</u> Either party may cancel the contract upon a 30-day written notice to cancel for no apparent reasons.

Bonds: No bid deposit or performance bond will be required for this bid process.

<u>Pre-Bid Meting</u>: There will not be a pre-bid conference held in connection with this bid package since it is believed that the specifications contained herein fully cover the purchase intent.

ALL QUESTIONS must be submitted electronically by means of the Q & A Feature included within this bidding event. NO QUESTIONS will be answered by telephone, email, written correspondence or other means except as described herein. Answers to electronic questions properly submitted will be sent out electronically by means of the above described Q & A feature to all properly registered suppliers who received the Initial Notification of bidding event. Those suppliers who registered after the Event Preview date and time will not receive electronic correspondence relative to this Event. There shall be **no communication** with any Guilford County employees other than by means of the Q & A feature. Violation of this requirement may invalidate your proposal.

<u>Terms and Conditions</u>: Terms and Conditions, the Non-Collusion Affidavit and the E-Verify Affidavit are attached to the event and should be reviewed carefully.

Specific Specifications

Stryker Performance Load ambulance cot mounting system.

This system device works in conjunction with the Stryker Power PRO XT and Performance – PRO XT stretchers
and meets the SAE J3027 recommendations to maximize operator safety in the event of an ambulance accident.
The Optimized Battery Management (Option) inductive charging optimizes Stryker SMRT battery management
when in transport position and is requested by Guilford County to have this option. (NO EXCEPTIONS or
ALTERNATIVE PRODUCTS)

Installation for retrofitting approximately 40 type I ambulances with the Stryker Performance Loading system with the Battery Management System.

• Installer must comply with ambulance manufacture specifications as well as Stryker's recommendations for mounting the Performance Load Ambulance Cot Mounting System. Installation must meet or exceed the SAE J3027. This installation will be conducted at a site owned by Guilford County and Guilford County will provide all materials needed to complete the installation process.

Stryker XPS expandable patient surface.

• This system works in conjunction with the Stryker Power PRO XT and Power-PRO TL. This up-fit increases patient surface area, is integrated into the cot system and enhances the safety of patients as well as comfort. Included within this up-fit kit is a new mattress designed to reduce the transfer gap when moving patients adding to the safety of patients and employees. This device will be added to Guilford County's current Stryker Power Pro XT stretchers. (NO EXCEPTIONS OR ALTERNATIVE PRODUCTS)

Stryker SMRT battery for use in the Stryker Power Pro XT Stretchers.

This battery is used in the Stryker Power PRO XT stretchers and is an Ni-Cad battery.
