The Guilford County Sheriffs Office seeks grant funding for equipment and overtime costs associated with covert operations pertaining to Human Trafficking cases in Guilford County.

The operation of this project relies on funding in equipment and overtime. Covert surveillance cameras or "Pole Cams" are necessary to put in and around a location where suspected trafficking is transpiring. This project seeks to purchase 2 pole cams for this purpose. The second piece of this project relies in overtime for officers involved in undercover operations. Funding for these officers will include overtime and fringes which are impacted by overtime to include retirement, FICA, and worker's comp. The operation of this covert project relies upon both surveillance equipment as well as overtime funding to enable undercover officers to investigate and execute operations to document evidence and arrest those involved in human trafficking within Guilford County. Further, victims will be referred to Guilford County's Family Resource center and trained professionals to address their immediate needs.

This project is summarized by establishing a covert operational plan that includes surveillance and undercover operations targeted at incidents of human trafficking within Guilford County.
