






## **GUARDIANSHIP SERVICE TRENDS**




## IN-HOME AIDE SERVICE TRENDS

## FREQUENTLY ASKED QUESTIONS

- Is there a fee for In-Home Aide/Adult Day Care Services? No, the services are provided without regard to income through the Home and Community Care Block Grant. Consumers can voluntarily contribute toward the cost of their services.
- Are family members that serve as legal guardian subject to financial responsibility? No, expenses should be paid from the adult's income.
- Will APS come immediately and handle my family crisis? The response time is determined by the nature of the situation. Most cases allow a 24 or 72 hour response from APS. An immediate response is one where the allegation is danger of death in an emergency situation as defined in G.S. 108A-101(g).



# FREQUENTLY ASKED QUESTIONS

- Is there a fee for DSS serving as Representative Payee? No, DSS provides this service without charge under SSBG/MAC funding.
- Can DSS serve as Representative Payee for Veterans? No, per the Veteran's Administration.
- Can DSS serve as Representative Payee for Special Assistance-In Home recipients? Yes
- Who should one contact to make a complaint about an adult care home? Call the Division of Health Service Regulation (DHSR) at 800-624-3004.
