Dear Major Williamson:

I hope this letter finds you well. Correct Care Solutions (CCS) is proud to be a partner with Guilford County and looks forward to continuing to provide medical care services at the Guilford County Jail facilities for the upcoming year.

As per Section 7 of our Contract, CCS respectfully requests to extend our contract for one additional year (July 1, 2017 – June 30, 2018), with an increase in the base contract amount consistent with the Consumer Price Index (“CPI”) for Urban Consumers – US City Average for Medical Care Services Component. This CPI rate currently stands at 4.0%; however, CCS agrees to a reduced increase of 3.0%. Application of the renewal increase is shown as Option 1 in the below pricing grid:
