Greetings,

Select Bank & Trust ("Bank") is pleased to offer to the fire department the following loan commitment. The terms of this commitment are as follows and will accompany other documentation necessary to execute our commitment.

**Borrower(s):** Northeast Guilford Volunteer Fire Department, Inc.

**Signer(s):** Brian Graves, as Board President, designated by the authorization from Chief Steve Apple dated July 21, 2017.

**Loan Type:** Equipment secured term loan.

**Loan Amount:** \$475,000

**Purpose:** To finance the purchase of a 2017 Spartan Star Pumper truck.

**Collateral:** First lien on the subject vehicle's title once it has been delivered and assigned a VIN number.

**Repayment:** Seven (7) year term, fifteen (15) year amortization. There will be six (6) annual payments of \$41,979, followed by one final payment of all remaining principal and interest due at maturity. Repayment is based on a fifteen year amortization.

**Rate:** The interest rate will be 3.75% fixed. The interest rate is based on the loan being tax exempt to Select Bank. Any change in the tax exempt status of the fire department could result in the interest rate being changed to a taxable equivalent rate.

**Insurance:** Borrower agrees to keep hazard insurance on the equipment serving as collateral for this loan as long as there is an outstanding balance on this loan. A binder will be required at closing listing Select Bank & Trust a "loss payee."

**Conflicting Provisions:** If any of the provisions of this commitment letter shall be construed to conflict with any terms or provisions contained in the Loan Documents, then the Loan Documents shall take priority.


Prayer was given by Chief Apple


