Re: Addendum to 2017-2018 Collector's Settlement

Charges to the countywide levy were \$339,116,166.94. Total amount collected for FY 2017-2018 ending June 29 was \$336,446,810.50 or 99.21%. Total amount uncollected was \$2,669,356.44 or 0.79%.

If we examine the representative tax types that make up the 99.21% overall collection rate, we see the following:

- Guilford Countywide Real Property Tax – 99.21%
- Guilford Countywide Individual Personal Property Tax – 86.04%
- Guilford County Business Personal Property Tax – 99.27%
- Guilford County Public Personal Property – 99.97%

Compared to FY 2016-2017 ending June 30, 2017, the collection rate for FY 2017-2018 increased 0.07% for real and non-RMV personal property.

In accordance with North Carolina General Statute 105-373(a)(2), titled Annual Settlement of Tax Collector – Insolvents, as of June 29, for the tax year 2017-2018, the following tax types are deemed as uncollectable:

- Business Personal Property Tax - \$243,142.33
- Individual Personal Property Tax - \$97,736.42
- Public Utilities - \$2,560.59
- Bankruptcies - \$16,484.97
- Appeals to the State Property Tax Commission - \$0.00
- Appeals to the Board of Equalization & Review - \$0.00

- Parcels affected by the Guilford/Alamance County line issue - \$19,164.21
- **Total - \$379,088.52**

The resulting collection rate less insolvents is 99.28%.
