Below please find (1) the brief project description for the Signature CTE academies that was provided for the Guilford County Board of Education, (2) student transportation plan (3) design estimate, (4) project timeline estimate, (5) program overview 2019-2020, and (6) district strategic and legislative priorities.

1. Project Summaries

Academy at Smith

Moderate renovation to existing classrooms and lab spaces into one (1) Mental Health classroom/CTE lab, and one (1) Pharmacy Technology classroom/CTE lab

Kearns Academy

Minor renovation to existing classrooms into one (1) Artificial Intelligence classroom/CTE lab, one (1) Geospatial Technologies classroom/CTE lab, and up-fit of an existing computer based classroom/CTE lab for Cyber Security program

Northeast High School

Up-fit of existing classrooms into one (1) Artificial Intelligence classroom/CTE lab, one (1) Geospatial Technologies classroom/CTE lab, and one (1) Cyber Security classroom/CTE lab

Smith High School

Build a new CTE building to include: one (1) Advance Manufacturing classroom/lab, one (1) Engineering classroom/lab, six (6) core classrooms, one (1) collaboration area, and faculty office space

Southeast High School

Major renovation to existing CTE space into one (1) Advanced Manufacturing CTE lab and one (1) Engineering Lab

Western High School

Moderate renovation of existing classrooms into one (1) Drone Technology classroom/CTE lab, as well as major renovation of an existing classroom into one (1) Diesel Technology classroom and build a new Diesel Technology Lab

2. Student Transportation

Students who live within a Signature Academy school zone will be transported to school via the GCS transportation department. We are working with the City of Greensboro and City of High Point to provide public transportation for students who reside within the city limits and wish to attend the Signature Academies at the Academy at Smith, Smith HS, Western Guilford HS, or Kearns Academy. Once public transportation is established, the GCS transportation department will provide transportation for students wishing to attend Signature Academies at Southeast Guilford High School and Northeast Guilford High School.

3. Design Estimate

We do not have a design estimate at this time. As you know, project design is generally 13% of total project cost.

4. Project Timeline

We expect construction to be completed by September 2021.

5. Program Overview

We will begin each Signature Academy with 40 freshmen students who will be taking their initial course work required for graduation and will not require advanced CTE labs during their first year of participation.

6. CTE Priority

CTE is indeed one of six priorities in the GCS Strategic Plan and is listed as one of our 2019 legislative priorities. Both are attached to this email.
