## Revision#1 Additional funding totaling \$206,156 was allocated as follows:

Guilford County Transportation increased General Transportation by \$3,156, Guilford County DHHS increased Personal Care LVL 1 \$13,690, LVL2 \$32,063 & LVL3 \$9,247. Senior Resources increased HDM by \$72,000 and Adult Ctr Enrichment began the Housing/Home Improvement program with \$25,000, increased ADH by \$26,000 and increased group respite by \$25,000.

**Revision #2:** Adult Center for Enrichment \$25,000 for HHI service discontinued and funds given to Senior Resources.

Senior Resources divided the \$25,000, increasing Congregate meals by \$10,000 and HDM by \$15,000.

**Revision#3: Guilford DHHS** moved \$66,244 from ADC. \$7,200 increased their Level II In-Home Aide. \$18,000 increased their LVL III In-Home Aide. \$41,044 was released. **Guilford Transportation** released \$23,000 in general transportation.

Senior Resources increased senior center operations by \$3,000 but reduced their HDM by \$10,000.

ACE increased Adult Day Health by \$50,044. Remaining \$21,000 converted to Legal and increased Guilford Legal Aide.
