In accordance with FTA C 9030.1E, the City of Greensboro, the Designated Recipient for the Greensboro, NC Urbanized Area authorizes the reallocation of a portion of its Federal Fiscal Year 2021 Section 5307 apportionment to the Piedmont Authority for Regional Transportation (PART) and Guilford County Transportation and Mobility Services (TAMS), as follows:

City of Greensboro FY2021 apportionment: \$5,335,506

Guilford County TAMS	\$35,000	Operating Assistance
City of Greensboro	\$4,947,882	Operating Assistance/ Preventative Maintenance

As identified in this Split Letter, the Designated Recipient authorizes the assignment/allocation of Section 5307 funds to the Direct Recipient and Sub-recipient named herein. The undersigned agree to the Split Letter and the amounts allocated/assigned to the Direct Recipient. Each Direct Recipient is responsible for its application to the Federal Transit Administration to receive Section 5307 funds and assumes the responsibilities associated with any award for these funds.

This sub-allocation of funding was developed through a collaborative process with local officials, operating through the Greensboro Urban Area Metropolitan Planning Organization (GUAMPO) and the City of Greensboro as the Designated Recipient. The process was fair and
