We have been advised that the 2021 American Rescue Plan Act (ARPA) apportionment for the Greensboro Urbanized Area is \$15,127,344 in Section 5307 funding. The table below indicates the distribution of funds between the transit agencies operating within the Greensboro Urban Area Metropolitan Planning Organization area. The safety and security apportionments are not calculated in the table below since transit agencies will not be applying for safety and security projects with this funding as other sources of funding are used by each agency to meet their safety and security needs.
