**THIRD ADDENDUM TO INTERLOCAL AGREEMENT ON TAX COLLECTION  
(EXTENDING TERM)**

This amendment, made and effective as of July 1, 2021, is an amendment to the Interlocal Agreement on Tax Collection made May 16, 2016 and effective July 1, 2016, as subsequently amended by an Addendum to Interlocal Agreement effective July 1, 2017 and by a Second Addendum to Interlocal Agreement effective January 1, 2020 (the current, resulting agreement being referred to as “the Interlocal Agreement”) between the City of High Point, a municipal corporation in the State of North Carolina (“CITY”), and Guilford County, North Carolina, a body politic and corporate ( “COUNTY”), collectively referred to as the “Parties.”

WITNESSETH

THAT WHEREAS, on May 16, 2016, the CITY and the COUNTY entered into an Interlocal Agreement on Tax Collection effective as of July 1, 2016, under which the COUNTY agreed to provide ad valorem tax listing and collection services to the CITY for a five (5) year term from July 1, 2016 through June 30, 2021;

WHEREAS, the CITY and COUNTY subsequently amended the original agreement by an Addendum to Interlocal Agreement effective July 1, 2017 and by a Second Addendum to Interlocal Agreement effective January 1, 2020;

WHEREAS, the CITY and COUNTY have determined that it is in the public benefit and interest to extend the term of the Interlocal Agreement for an additional three (3) years on the same terms; and

WHEREAS, the governing bodies of the CITY and COUNTY have ratified this amendment to the Interlocal Agreement by resolutions recorded in their respective minutes;

NOW, THEREFORE, in consideration of the mutual covenants, terms and conditions contained in the Interlocal Agreement, as amended, accruing to the benefit of each of the Parties and other good and valuable consideration, receipt and sufficiency of which is acknowledged by the CITY and the COUNTY, the Parties agree as follows:

1. The term of the Interlocal Agreement is amended and shall be for eight (8) years, from July 1, 2016 to June 30, 2024, unless sooner terminated pursuant to its terms.
2. Section 5. Records and Accounts, Subsection (b), is replaced by the following:

(b) The CITY will provide the COUNTY with all necessary information for ACH transfer for all funds due the CITY and the COUNTY will properly account for and initiate an ACH transfer or other mutually agreed upon method on a daily basis and notify the CITY Finance Department by 10:00 a.m. or as soon thereafter as feasible of amounts to be transferred.

3. All other provisions of the Interlocal Agreement and any subsequent modifications and revisions are ratified and shall continue in full force and effect in accordance with their terms.

IN WITNESS THEREOF, the Parties have executed this Third Addendum to Interlocal Agreement in their respective names and titles, by their proper officials, all by the authority of appropriate resolutions of the governing bodies of each of the taxing units, duly adopted, as of the day and year first written above.
