



**SUBSCRIPTION RENEWAL ADDENDUM
TO
SUBSCRIPTION LICENSE AND SERVICES AGREEMENT
BETWEEN

Successor in interest to Infor Global Solutions (Michigan), Inc.
AND
GUILFORD COUNTY (“Licensee”)**

This Subscription Renewal Addendum effective as of **09/01/2021**, (the “Effective Date”), sets forth terms and conditions that are in addition to and/or modify those terms and conditions set forth in the Subscription License and Services Agreement between Infor, and Licensee, dated May 13, 2014, (the “Agreement”). In case of any conflict between the Agreement and this Addendum, the terms and conditions of this Addendum shall control. Except as otherwise modified herein, all terms and conditions of the Agreement shall remain in full force and effect.

The parties agree as follows:

1. For the period commencing September 1, 2021 and ending August 31, 2022 (the “Subscription Term”), Licensee agrees to pay the Annual Subscription Fee as specified below. The applicable sales tax will be included at the time of invoicing.

2. The Annual Support Fee set forth herein applies only to the items on **Exhibit A**. If Licensee licenses additional Component Systems and/or users during the Subscription Renewal Term, the Annual Subscription Fee shall increase accordingly.
