#### **BACKGROUND**

In August of 2018 a new brand for Central North Carolina was introduced. The Carolina Core is a bold vision to build regional awareness for Central North Carolina with the goal of major company expansions and relocations to our region. Designating US 421 as a future interstate corridor will be foundational to the success.
