BACKGROUND

The Guilford County Sheriff's Office is requesting approval to purchase Law Enforcement vehicles from the listed dealers and contracts numbers:

The purchase will not exceed \$1,010,000. These vehicles are replacing aging vehicles, due to high mileage and increasing maintenance costs.
